

Movie lights shine

Film industry expanding in Newburgh

UMBRA Stages of Newburgh and ChoiceFilms continue to expand the film industry in the greater Newburgh area.

The UMBRA Stages are managed and operated by Tony Glazer

and Summer Crockett Moore of Newburgh. According to his biography page, Glazer is an award-winning writer, director and producer. According to her website, Moore is an award-winning actress and producer.

In 2011, Glazer and Moore partnered with current owners of the stages,

Ted Doering, and his partner, Jean Lara to take over the management of the stages. That same year, Choice Films at UMBRA Stages was born.

“When we arrived, there was only one stage with limited infrastructure,” Glazer said. “Under

Town board rejects Coldenham overlay district

A proposed zoning change that would have allowed higher density development in the East Coldenham area has been rejected by the Newburgh Town Board.

Residents brought their concerns to the town board in February, regarding the proposed East Coldenham Overlay District. Most of the comments during the hybrid public hearing came from residents of Colden Park who expressed concern about the traffic impact, construction of structures and types of business that could come in if the zoning change were approved.

our management, the stages have grown to three active and fully booked stages with three more stages currently under construction.”

UMBRA has worked on several productions that include Hometown Kickstart for HGTV, White House Plumbers for HBO, and The Pale Blue Eye for Netflix.

In the early days of the pandemic, Glazer said he was very apprehensive and uncertain about the future of the film industry. Now with health guidelines in place, UMBRA Stages operates again with full production. “I never lost hope, I always knew we would all find a way to adjust and live with this ‘new normal,’” Glazer said.

Since UMBRA’s first days of operation in the greater Newburgh area, the reaction and reception of their work has been positive. Now, Glazer hopes that UMBRA can perform and provide more outreach to the local Newburgh community and connect with residents.

“I mean it when I say that we want the success of the film industry here in Orange County to be a success for everyone,” Glazer said.

Within UMBRA, the company offers work opportunities in security work, production assistance, and to be a part of the office staff.

the Line Bootcamp. The Below the Line Bootcamp, according to the website, is a non-profit program that offers the opportunity for anyone interested to learn more about the production field. Once completed, graduates can expect entry level work and advancements in career opportunities in the production and film industry.

For Macy Clarke, an assistant prop master, despite having a degree in TV production, she did not enter the production field immediately.

It was through a former teacher that she was able to meet Glazer and Moore and attended the boot camp and has been working for UMBRA for a year.

For Clarke, having both Glazer and Moore not only help support her career but also during the pandemic, she is

grateful to have them as resources and support.

“In an ideal world, I would work with Summer and Tony for the rest of my career, just because they are great people,” Clarke said.

As a Newburgh resident, she recognizes that if more people from her community learned more about the opportunities that UMBRA offers, the interest can grow and jobs can lead to new career opportunities.

For the past year, Andrew Lopez has been working at UMBRA full-time, working a variety of jobs and learning new skills along the way.

As a former student of the boot camp, he remembers taking a tour of the stages, speaking to a variety of professionals from the industry, and

learning about the ins and outs of the field.

It was in college that Lopez first met Glazer and Moore and was cast into a role for a production.

As Lopez continues to work with UMBRA, his interest in the film industry has grown and he is thankful to have been given the opportunity to break into the film industry.

Lopez’s goal is to see a written work or creation of his be made or produced later on in his career.

An accountant at ChoiceFilms, Brandon Scott also first started working with the company after attending the boot camp.

Working alongside Glazer and Moore has been a great experience and he is happy to be working at UMBRA.

“They’re [Tony and Summer] hands down the best bosses I’ve ever had and probably will ever have,” Scott said.

For Scott, while he enjoys accounting, he also enjoys video editing and working in production has always been a dream for him.

Within the Town of New Windsor, the former Tarsio Lanes building, a former used car sales lot, the former Anthony’s Pier 9 venue and another commercial lot along New York State Route 9W are proposed locations for new stages to be constructed.

According to Glazer, UMBRA will go before the Town of New Windsor Planning Board for public hearings and the goal is to have these spaces operational by the fall of this year.

overlay to move forward,” said Town Supervisor Gil Piaquadio in a statement released last week. “Therefore, at this time the zoning remains the same as it has been since 2009.”

In 2009, the Town Board rezoned more than 2,300 acres in the western area of the Town from R-3 Residential (up to 6 to 9 dwelling units per acre) and R-2 Residential (small lot) to R-1 Residential (one home per “builder’s acre”).

The reasons for the change included preserving the character of the existing residential areas, the absence of a north-south highway corridor in the western area, reducing the growth impacts on the Valley Central School District, reducing traffic impacts on Route 17K and reducing friction between

residential and commercial development.

Piaquadio said the change was adopted successfully despite court challenges. Another area to the south of Route 17K between I-84 and Windwood Drive was rezoned from IB Interchange Business to B Business due to the area’s close proximity to residential neighborhoods and the desire to promote residential services.

Owners of vacant commercial properties on Route 17K, including the former home of a strip club, and potential commercial developers have informally approached the Town Board to inquire about rezoning their properties to allow for higher residential densities like that allowed under the prior R-3 zoning and also to allow warehouse development in the area now zoned B.

“The Town Board has not looked favorably upon

those requests,” Piaquadio said.

In reviewing one of those requests and in accordance with the Town’s Comprehensive Plan, the Town Board decided to consider allowing a mixed use on sites at least 10 acres in size along Route 17K. The mixed use would consist of some retail stores, offices and personal services and some residences at a lower density than would be possible under the R-3 Zoning. More residential units could be obtained if actual dry, usable acreage was offered and accepted as a park, but the number of residences that could be obtained would not be nearly the same as what could be built under R-3. This mixed use would be authorized as a zoning district overlay which would not change the underlying zoning.

The Town’s Planning Board would have to review and approve the proposed site development plan.

State Police investigating laser pointed a commercial aircraft

On April 4, the New York State Police were contacted by a Supervisor at Boston Control Tower in New Hampshire regarding a laser being pointed at an aircraft near Stewart International Airport in the town of New Windsor. The Supervisor at the Boston Control Center stated that a commercial passenger flight was northbound over Stewart International Airport when the pilot reported a laser was shined at the front left of the aircraft. The laser reportedly came from an unlit area between Stewart Airport and the Hudson River.

The pilot of the aircraft was later interviewed by New York State Police Investigators. He stated that he was flying Republic Airways E1-70 aircraft northbound when a green laser was pointed at the left area of the cockpit. The pilot stated at his altitude was approximately 17,000 feet at the time of the incident.

Harley collides with SUV

On April 4 at approximately 3:45 p.m., Town of Newburgh Police responded to a motor vehicle accident on Rt 300 in the Town of Newburgh at the entrance to Walmart. Police arrived on scene to find that a motorcycle had collided with a car at the intersection to Walmart.

Steven Gordon, 57, New Windsor, was operating a 2005 Harley Davidson traveling southbound on Rt 300 when a 2013 Nissan Pathfinder, driven by Rosalba Garcia-Sanchez, 30 of Newburgh, attempted to make a left hand turn into Walmart from traveling northbound Rt 300. As Garcia-Sanchez made the left turn, Gordon's motorcycle collided with her car, causing Gordon to be ejected from his motorcycle.

Gordon was treated at the scene by TONVAC and prepared for Medevac to Westchester Medical Center where he is being treated for injuries suffered in the accident.

At this time, there are no charges or tickets issued as the case is still being investigated.

Skoufis to seek third term

State Senator James Skoufis (D-Cornwall) formally launched his reelection campaign this week, having hand-delivered petitions to the State Board of Elections on Monday. Nearly 4,000 signatures - four times the required amount - were collected to earn him a space on the Democratic Party ballot line. Skoufis' supporters also collected more than double the required number of signatures to appear on the Working Families Party ballot line. In his first two terms in the State Senate, Skoufis successfully fought to make the property tax cap permanent, ensure equal pay for women in the workplace, strip the power of pharmaceutical 'middle men' in order to drive down prescription costs, and expose misuse of taxpayer dollars within New York's failed system of 'economic development.'

"In my first two terms, we've been able to accomplish so much together on behalf of local communities," said Skoufis. "As the state faces both challenges and opportunities, I would be humbled if given the opportunity to continue fighting for the Hudson Valley and all of our constituents for another two years."

Mount Saint Mary College will honor the life and legacy of longtime professor James Finn Cotter on Sunday, May 1, at 2 p.m.


Cotter passed away on January 8, 2022, at the age of 92.

The event will celebrate Cotter's life and accomplishments with readings and prayer in the Chapel of the Most Holy Rosary in the Dominican Center, followed by a reception.

Also at this link, donations can be made in his memory to the newly established Dr. James Finn Cotter Memorial Scholarship, which will be bestowed on students in need who are pursuing a degree in English.

For nearly 60 years, Cotter shared his knowledge and talent with the Mount campus, teaching students poetry and literature. A distinguished author and educator, his commitment to the growth of the college

and its students was unwavering.

Known to his pupils as "Dr. Cotter" and to his many friends and colleagues as "Jim," Cotter changed the lives of thousands of Mount students before his retirement from the Mount in the late summer of 2020.

"It fills me with joy to watch my students grow as they developed a love of poetry, literature, and scholarship," Cotter said in a recent interview.

When he wasn't teaching or aiding with administrative tasks for the college, Cotter delved into his own scholarly work. He was a celebrated translator of Dante's *Commedia*, which he began on the backs of envelopes and scrap papers early one Christmas morning in the 1980s before his children woke up. Among a great many other publications, Cotter authored *Beginnings: The First Twenty-Five Years of Mount Saint Mary College* and *A New Life: Learning the Way of Omega*.

Outside of academia and his personal pursuit of wisdom, truth, and compassion, Cotter volunteered at the Newburgh Free Library; assisted as a Eucharistic minister for St. Mary's and St. Patrick's; and wrote reviews of local plays and concerts for local newspapers. He also loved hiking and nature, often using his experiences outdoors as a base for his poetry and prose.

"James Finn Cotter's legacy is truly part of the DNA of the college," said Dr. Jason N. Adsit,

president of the Mount. "We are so thankful to have had the honor of knowing this wonderful man and his memory will be cherished by all."

Battle against children's cancer continues on April 23

On Saturday, April 23, the 15th Annual Hudson Valley St. Baldrick's event will be held to help those fighting childhood cancer. The event will take place at the Walden Fire Department, 230 Old Orange Avenue, beginning at 2 p.m. and will include head shaving, music, food, face painting, 50/50 and a tricky tray.

St. Baldrick's Foundation is a volunteer and donor driven charity committed to research and finding cures for childhood cancer. Hudson Valley St. Baldrick's Volunteer Event Organizer Kristie Hall, along with fellow volunteer organizers Tina Quinlan and Tabitha Bliss, work together with their committee to make the event successful every year.

Hudson Valley St. Baldrick's started nearly two decades ago when Walden resident and Hall's cousin Robbie Brown attended the event in North Carolina while visiting a relative. Brown loved the idea, and

when he came home, Hudson Valley St. Baldrick's came to life in memory of Megan Dunn - Robbie and Kristie's cousin. Each year at the event, Megan's Aunt Mary Kate McNamee sets up a table, pictures and memories she has of Megan. She is joined by volunteers with Team Union House to provide the delicious food and raise money in memory of Megan. This year, Megan's mom, Joann McNamee will be shaving once again in memory of her daughter.

The event is a fan favorite because all ages are able to participate. "Kids and adults of all ages can be involved and while the head shaving event is our main event, you can shave a beard, get a little cut or however you want to help," explained Hall. "The funds that we raise every year go back to the main organization and from there they are given to local facilities that benefit children with cancer in the form of grants and research to help fund clinical trials." Recipients include the Philadelphia Children's

Hospital, Memorial Sloan Kettering Cancer Center, and Maria Fareri Children's Hospital in Westchester among others in the tri-state area which directly benefit Hudson Valley children and their families.

Hall shared that the Covid pandemic hurt the fundraising efforts over the past two years and the impact is still being felt this year, but event organizers are hopeful that this year will be successful. "Covid unfortunately really hurt us quite a bit. In 2020, we ended up needing to postpone the event and had a virtual option and last year's event kept getting pushed back," Hall explained. As of November 2021, the Hudson Valley St. Baldrick's event raised over a half a million dollars locally.



The lucrative business of professional sports

Those of us of a certain age, or perhaps our parents, grandparents or older siblings, remember the heartbreak caused in 1957 when the Brooklyn Dodgers packed up and moved to California.

As the story goes, Walter O'Malley, owner of the Dodgers, wanted a new stadium in downtown Brooklyn to replace the aging, but beloved Ebbets Field. The City of New York suggested a more suitable location for a new ballpark would be Willets Point in Flushing, Queens, near Flushing Meadows Corona Park. While Queens would eventually become the home of the New York Mets, it wasn't good enough for the Dodgers who eventually were given land from the City of Los Angeles to build a new stadium.

Since that time, the fear of losing the local team has prompted drastic action in many cities, as the business of professional sports continues to grow. A deal was announced last week that will keep Governor Kathy Hochul's hometown team, the Buffalo Bills in Western New York for at least the next 30 years. The deal calls for the State of New York and Erie County to invest \$850 million into a stadium for the Bills, marking the largest public investment into a National Football League stadium. Total cost of the new stadium is expected to be \$1.4 billion, with the Bills and the NFL funding the rest of construction through the exorbitant sale of seat licenses to potential season-ticket holders.

The lucrative stadium deal doesn't guarantee the Bills their first Super Bowl appearance since 1994, but there is plenty of money to be made from stadium concessions, parking, sales of team merchandise and of course, sales of tickets and the aforementioned seat licenses that, according to the Buffalo News, will start at \$1,000 apiece. (The Los Angeles Rams reportedly charged \$100,000 for seat licenses for their new stadium.)

The owners of the Bills, Kim and Terry Pegula of Boca Raton, Fla., are not poor. They are worth a reported \$5.8 billion and don't need public assistance. They will likely get much richer for their ventures into professional sports and don't need our help to do so.

Questions remain unanswered

The Cornwall CSD Board of Education continues to move forward with a bid to spend \$8 million of taxpayer money on a sport facility at the high school. Community members have raised significant concerns regarding this project in relation to health implications, environmental ramifications, and safety issues, yet these concerns and questions go unanswered.

The turf expert hired by the district to answer questions is not a medical doctor, so concerns regarding the impact of carcinogens associated with artificial turf go unanswered. The research studies cited by Dr. McNitt in his presentation dated back to 2010 and before. There is a body of research done after 2010 indicating hazards in relation to children's

exposure to carcinogens via synthetic turf. Given that he is not a medical doctor, which he stated numerous times during his presentation, it is confusing as to why Dr. McNitt saw fit to discuss medical studies and implications. More disturbing is that the board accepts his input on this topic. It is interesting that the last question on the district's Q&A sight about these concerns remains unanswered - https://www.cornwallschools.com/apps/pages/index.jsp?uREC_ID=506485&type=d&termREC_ID=&pREC_ID=992286

Concerns regarding carcinogens in relation to water run-off into the nearby state designated wetland and groundwater were also raised by area residents. The chemical PFAS, which is the known

carcinogen that spoiled the city of Newburgh's water source – Washington Lake – has been found in significant levels in the water run-off from artificial turf fields. In Woodbridge, CT testing indicated a significant increase in several types of PFAS in surface water adjacent to the artificial turf field at Amity High School. Surface water eventually enters the ground and eventually aquifers. Area residents use wells for drinking water. When these wells become contaminated, will the district pay to remediate the problem?

The question of traffic in and out of the single exit at the high school has also been raised by numerous residents. Traffic is bumper to bumper both on Rt. 94 as well as on Dragon Drive every morning during student arrival. There have been several accidents at the intersection of Rt. 94 and Dragon Drive, yet there have been no answers from the district as to how traffic will be addressed during large turnout sporting events.

At what point in time will the district respond to these concerns?

No mow May

In the Netherlands concern over the dangerous decline in bees led to National Sowing Day beginning in 2017. Free organic flower seeds are distributed by 1500 volunteers. Each seed packet contains a variety of flowers attractive to pollinators.

Founder Tom van de Beek notes that, "Bees are struggling everywhere and they can be fed everywhere. We started this program in the Netherlands but that doesn't mean it also ends in the Netherlands because the problem is global."

Members of groups in this country are urging something even simpler: No Mow May. You don't

have to do a thing and you'll still help bees! Just don't mow part of your lawn and once flowers arrive, so will the bees. Concerned about your property looking messy? Just mow the borders, even display a Pollinator Pathway sign, and neighbors will see the orderliness of your intentions.

No Mow May will not only save the bees that pollinate our food source, but will cut down on greenhouse gas emissions. And if you were someone using neonics to kill insect pests, you may have been killing bees, since one square foot of grass could absorb enough neonics to kill one million bees.

So, take the lazy way out! Don't mow (much), water, fertilize or spray and give bees a chance. And remember, when foraging for pollen, bees have no interest in stinging you.

NEWBURGH HERITAGE

A scientific friendship that changed history

Benjamin Franklin was profiled by acclaimed filmmaker Ken Burns this week in a new documentary that aired on public television. The story of Franklin's life is ripe with drama and connection to the timeline of early America. Mr. Franklin is one of the most recognized of the "founding fathers," with his portrait on a one-hundred dollar bill and his words quoted more often than most recognize.


Mr. Franklin was brilliant in politics, governing, literature and culture. He is known as a printer in colonial Philadelphia whose weekly almanac was full of sage advice and practical science. He was recruited to join the separatist movement to form a new nation and led thousands with his wise ideas and his natural diplomacy. School children were long told that he "discovered"

electricity by experimenting during a lightning storm, lifting a metal key up into the sky on the string of a kite. That may never have happened but he did imagine doing just that in an article he wrote.

Few know that Ben Franklin had a Newburgh friend and that they corresponded often. Cadwallader Colden, who lived on a farm in the Town of Newburgh was, like Franklin, a man of The Enlightenment, the 18th century intellectual revolution that believed rational thought could improve humanity by employing reason and the scientific method. Mr. Colden emigrated from Scotland in 1715 to join an aunt who had already crossed the Atlantic. He saw opportunity in America and returned home to marry his sweetheart, Alice Chryste and bring her back with him. Colden had been educated at Edinburgh University as a physician where he had also studied all the physical and natural sciences. In 1720, he was recruited by the New York Governor General to survey lands in this colony and he and Alice moved from Philadelphia. Alice, too, was a graduate of the University of Edinburgh, a rare feat for a woman of the early 18th century. Together, they accepted a land grant west of the little Parish of Quassaick and settled there to raise their family. Alice and Cadwallader taught their children at home where the ten children benefited from their parents' unusually high educational background. Daughter Jane eventually focused on botany and was America's first woman botanist, compiling a catalog of native plants using the new nomenclature

just being developed by Swedish scientist Carl Linneus. Cadwallader Colden was the first colonial representative to the Iroquois Confederacy and his travels to the southern tier caused him to be the first to suggest the concept of an Erie Canal (realized long after his death). In his travels surveying New York colonial lands, he saw other issues that he hoped to address, such as public health and sanitation and communicated those needs to the governor and colonial legislature.

Colden read Benjamin Franklin's writings and they carried on a long and detailed correspondence through the 1750's. Thus, ideas flowed from Newburgh (by the 1750's that had become this town's official name suggested by Colden) to Philadelphia and back again. The men remained friends through the advancing changes happening in the colonies and abroad. Their letters shared news of their scientific experiments and their ideas for innovation.

It is fun to read their correspondence with thoughts fresh from each of their minds on topics

of physics and even the 1751 dream of exploring a "northwest passage" by ship.

They obviously respected each other's opinions and were mutually tinkering with the source of electricity, how it is conducted from place to place and the possibilities of storing its power in rudimentary battery systems. As Colden develops some test equipment for his home laboratory out on the Cohecton Turnpike, Mr. Franklin writes to him: "Your skill and expertness in mathematical computations will afford you an advantage in these disquisitions that I lament want of, who am like a man searching for something in a dark room, where I can only grope and guess while you proceed with a candle in your hand." Yet, the history books link not Newburgh's Cadwallader Colden with electrical genius but his friend, the venerable founding father, Benjamin Franklin.






The life of George Inness

Last week, I gave you the short story of the Gillies family. I mentioned Jacob Gillies had purchased his farm from the Inness family, so let's take a look at them, especially since a rather renowned artist was born there, George Inness.

I know many of you will recognize

this name, and many of you have viewed in awe his mastery of colors and painting.

He is considered by some to be "the father of American landscape painting". His father, John William Inness (b.

1792, d. 1873), originally came from Scotland, and his mother was Clarissa Baldwin (b. 1794, d. 1841). They were married in Manhattan on November 17, 1814.

Shortly thereafter, they moved to Newburgh. George was born here, in the wilderness which was our Town, on May 1, 1825. He had two brothers, and one sister. John William Inness tended to move about, perhaps this wanderlust is in the family's DNA, and by the time George was 5, the farm was sold to Jacob Gillies, and the Inness family headed to Newark, New Jersey. It was here George began to learn and develop his techniques of drawing and painting.

George was subject to epilepsy. He moved to New York City at the age of 16, to study engraving, but his health forced him to return to the family home, and resume his devotion to drawing and painting there. At the age of 20, he spent a month in New York City, studying with Regis Gignoux. And, thus concluded all the formal training he had, but the passion for his art, his natural ability to capture

images on canvas landscapes, continue to develop and evolve.

This artist wasn't content to just sit around, and he began his exploits and travels, beginning with a couple of trips to Europe, living in Florence and then Rome for a period. Never content, he returned to the states and settled in Boston for a time. It was then onto Perth Amboy, New Jersey. Not satisfied there, he relocated to New York City for a brief interlude before sailing over to Italy and residing there from 1871 to 1875.

George fell in love and married a lady, Delia Miller. Sadly, she passed away the same year, shortly after the union in 1849. In 1850, he took his second wife, Elizabeth Abigail Hart (b.

1833, d. 1903). This union produced two daughters and one son.

George's thirst to experience new scenery and places fueled his desire to travel. He was quite prolific and there are well over a thousand pieces of his artwork proudly being displayed around the world to this day. The next time a period landscape captures your gaze somewhere, take a look and see if his signature is there. Though he only spent the first five years of his life here, his love of the Hudson Valley and Catskills is evident in work, which he continued to put on canvas, being associated with the Hudson River School of Painting.

While on a visit to his ancestral homeland, Scotland, on August 3,

1894, George passed away. According to some records, George and his son were standing of the Bridge of Allan, Stirlingshire, Scotland, appreciating a sunset. Suddenly, as they were admiring the beauty of nature, George threw up his hands in the air and exclaimed "My God! Oh, how beautiful!" He then fell to the earth, leaving this world a few minutes later.

I have to believe his love of the natural world about him began here in our Town. Thanks, George, for grasping all the moments of your time, using your brush and oils, to preserve them for us to enjoy for the ages.



After Amo passed, Nettie continued with the deli and she loved all her devoted customers. Together with Amo, their life's work was the deli and the community, and the deli generously donated to Big Brothers and Big Sisters, Relay for Life, St. Jude, all the local bowling houses, soccer and Little League teams.

After Nettie passed, Cindy lovingly continued to run the deli as well as her nursery school, Miss Cindy's Neighborhood Nursery School. And

doing what she does best, keeping all her precious friends healthily fed and happy, all of her life. The end of the deli is on April 7, 2002. Let's wish Cindy, Scott and Joseph a fantastic fun-filled future with free time and relaxing vacations, and let's also wish Amo Jr. blessings for the future.

Newburgh is a much richer and kinder community because of the magnificent Gironda family. Thanks for the memories.
