#### **ADMIRAL LINDA L. FAGAN**

#### COMMANDANT **UNITED STATES COAST GUARD**

dmiral Linda L. Fagan assumed the duties as the 27th Commandant of the United States Coast Guard on June 1, 2022. As Commandant, she oversees All global Coast Guard operations and 42,000 active-duty, 7,000 reserve, and 8,700 civilian personnel, as well as the support of 21,000 Coast Guard Auxiliary volunteers.

She previously served as the 32nd Vice Commandant. Prior flag assignments include Commander, Pacific Area, and Commander, Coast Guard

Defense Force West; Deputy Commandant for Operations, Policy, and Capability; Commander, First Coast Guard District; and a joint assignment as Deputy Director of Operations for Headquarters, United States Northern Command.

Admiral Fagan has served on all seven continents, from the snows of Ross Island, Antarctica, to the heart of Africa, from Tokyo to Geneva, and in many ports along the way. Operational tours include Commander, Sector New York, more than 15 years as a Marine Inspector, and sea duty in U.S. Coast Guard Cutter Polar Star, a 399-ft. heavy polar icebreaker. Staff assignments include Executive Assistant to the Commandant and Vice Commandant, and Division Chief of the Foreign and Offshore Compliance Office.

Possessing extensive interagency as well as intergovernmental experience, Admiral Fagan has worked with both the International Maritime Organization and International Labor Organization on flag state and port state issues. This work includes the development of the International Ship and Port Security Code (ISPS), and the Consolidated Maritime Labor Convention.

Admiral Fagan holds a Bachelor of Science in Marine Science degree from the U.S. Coast Guard Academy, a Master of Science in Marine Affairs degree from the University of Washington, and a Master in National Resource Strategy degree from the Industrial College of the Armed Forces. She has earned numerous personal and team awards during her 37 years of Coast Guard service. Admiral Fagan is the longest serving active-duty Marine Safety Officer and holds the distinction of being the Coast Guard's first-ever Gold Ancient Trident.



#### **ADMIRAL STEVEN D. POULIN** VICE COMMANDANT **UNITED STATES COAST GUARD**

dmiral Steven D. Poulin assumed the duties as the 33rd Vice Commandant on May 31, 2022. As the Vice Service Chief and Chief Operating Officer, Admiral Poulin executes the Commandant's Strategic Intent, manages internal organizational governance and serves as the Component Acquisition Executive.

He reports to Coast Guard Headquarters from a tour as the Commander,

Atlantic Area, and Commander, Coast Guard Defense Force East. He concur-He served as Commander of Coast Guard Sector Mobile, where he directed Coast Guard operations in

rently served as Director, Department of Homeland Security Joint Task Force East. Prior flag assignments include U.S. Southern Command's Director of Operations, Commander of the First Coast Guard District, Judge Advocate General and Chief Counsel of the Coast Guard, and the Director of Governmental and Public Affairs. Mississippi, Alabama, and the Florida panhandle and was the Incident Commander for the Deepwater Horizon oil spill response operations in that same geographical area from April to October 2010. His previous operational tours include Deputy Commander, Coast Guard Sector Mobile, Alabama; Deputy Commander, Coast Guard Group Galveston, Texas; Law Enforcement Officer and Assistant Operations Officer at Coast Guard Group Mobile, Alabama; and as Deck Watch Officer on USCG Dauntless (WMEC-624).

Admiral Poulin has served in numerous staff and special assignments including, the Chief, Office of Maritime and International Law; Special Advisor for Border and Transportation Security in the Office of the Vice President; the Coast Guard's liaison to the State Department's Office of Ocean Affairs; Legal Counsel for the Coast Guard's Port Security Director; and Legislative Counsel in the Coast Guard's Office of Congressional Affairs. He also served on the U.S. delegation to the Legal Committee of the IMO and the Coast Guard's General Law Division.

Admiral Poulin graduated from the U.S. Coast Guard Academy in 1984 with a Bachelor of Science in Management. He was awarded his Juris Doctor, magna cum laude, from the University of Miami School of Law in 1992. Other degrees include: Master of Law (Environmental Law), with highest honors, from the George Washington University Law School in 2002; Master of Strategic Studies from the U.S. Army War College in 2005; and Master of Public Administration from the University of South Alabama in 1989. His military decorations include the Coast Guard Distinguished Service Medal, Defense Superior Service Medal (two awards), Legion of Merit (five awards), Meritorious Service Medal (four awards), Coast Guard Commendation Medal (three awards), and Coast Guard Achievement Medal.

aster Chief Heath B. Jones assumed the duties of the 14th Master Chief Petty Officer of the Coast Guard on May 19, 2022. Master Chief Jones is the senior enlisted member of the Coast Guard and the principal advisor to the Commandant on all personnel matters.

MCPOCG Jones is a native of Covington, Louisiana. He enlisted in the Coast Guard in August of 1995. Master Chief Jones' previous assignments include

Command Master Chief, Deputy Commandant for Mission Support; Command Master Chief, Pacific Area; Command Master Chief, Eighth Coast Guard District; Command Master Chief, Sector Hampton Roads; Officer in Charge, USCGC Sea Horse; Officer in Charge, Station Pensacola; Officer in Charge, U.S. Coast Guard Cutter Bollard; Officer in Charge, Station Cape Charles; Executive Petty Officer, Station Little Creek; Executive Petty Officer, U.S. Coast Guard Cutter Seahawk: Station New Orleans: U.S. Coast Guard Cutter Kanawha.

CMC Jones's personal awards include five Meritorious Service Medals, five Coast Guard Commendation Medals, two Coast Guard Achievement Medals, the Command Afloat and Ashore Devices, and the permanent Cutterman, Coxswain, and Advance Boat Forces insignia. He is the recipient of the 2012 Signalman First Class Douglas Munro Inspirational Leadership Award and the 2006 Master Chief Petty Officer Angela McShan Inspirational Leadership Award.

CMC Jones is a proud graduate of the Coast Guard Chief Petty Officers Academy Class 124, the Coast Guard Senior Enlisted Leadership Course Class 48, and he is a Keystone 18-1 Fellow. He holds both a Bachelor and a Master of Arts Degree in Organizational Management with a specialty in Human Resource Management. He also holds a Certificate of Apprenticeship as a Master Homeland Security Specialist from USMAP. In addition, he serves as a member of the Coast Guard Mutual Assistance Board of Directors.

He has been married to the former Carol Ann Clarke of Folsom, Louisiana, since 1996. They are the very proud parents of son Christian, attending Graduate School at The University of New Orleans, and daughter Sidney, attending Louisiana State University Medical School in New Orleans.

## AWARDEE

#### **GRAND COSTA D'AVORIA FIRE UNIFIED COMMAND**

The Coast Guard Foundation is proud to honor Coast Guard Sector New York and the Unified Command that responded to a fire on a vessel in the Port of Newark in July 2023. At approximately 9:30 p.m. on Wednesday, July 5, a fire broke out on the motor vessel Grande Costa D'Avorio in the Port of Newark. The crew of the vessel immediately activated on-board fire suppression procedures and alerted the Newark Fire Department. The vessel was completing cargo operations of loading automobiles when the fire began. The vessel was carrying more than 1,200 vehicles and 134 containers at the time of the fire.

Firefighters from the Newark Fire Department began the initial response, which eventually included teams from other New York and New Jersey fire departments. Sector New York command center personnel coordinated Coast Guard assets and laid the groundwork for what would become weeks of battling the fire and salvaging the vessel. Sector New York, subunits Station New York, the Cutter Line, the Cutter Hawser, and a host of other federal, state and local agencies also responded.

Shipboard firefighting brings unique complexities and inherent dangers not normally associated with responses on shore and two brave Newark fire fighters died and several other responders were injured in the early hours of the response.

As lead Federal On-Scene Coordinator, Captain Zeita Merchant stood up the Unified Command with expert representation from the Port Authority of New York and New Jersey, Newark Fire Department, Gallagher Marine and DONJON-SMIT, the representative of the vessel operator. The Unified Command brought in the Coast Guard's Atlantic Strike Team and Salvage Engineering Response Team to help develop the fire response and salvage plan.

The Unified Command's priorities were to ensure the safety of the public and first responders, fight the fire, protect the environment, and minimize disruptions to the port. Firefighting crews worked heroically from the pier and waterside to extinguish the fire and gain access to the upper decks of the vessel. At the same time the Newark Fire Department and New Jersey Department of Environmental Protection monitored air quality to ensure safe working conditions and public safety.



As the response continued into Friday and the vessel began to list, salvage teams removed firefighting water from the vessel to keep it from capsizing. Coast Guard responders also searched for potential pollution in the waterways and enforced a security zone to limit vessel traffic in the port for the safety of the first responders and the public. The Unified Command continued to fight the blaze throughout the night Friday and early Saturday and firefighters contained the fire on the 11th deck and stopped its spread. In addition, successful dewatering stabilized the vessel.

Through the coordinated efforts of Sector New York, members deployed to support the response, and the multitude of port partners over six days, the fire was extinguished. At the same time salvage crews continued to dewater the vessel and monitor its stability. The Coast Guard opened the Port of Newark to normal traffic that evening, further mitigating impact to maritime operations.

With the fire out, the Unified Command stood down and the Coast Guard began investigating the cause of the fire and directing salvage activities to safely remove the vessel from Port Newark. The fire at Port Newark was a tragedy that will impact the community into the future as we continue to mourn the loss of brave firefighters Augusto "Augie" Acabou and Wayne "Bear" Brooks Jr. Their selfless service and sacrifice while going toward danger will forever be held in the highest esteem.

The passion and diligence of Coast Guard Sector New York team and their partners are in keeping with the definition of the Coast Guard motto Semper Paratus.



# **YOUR IMPACT IN 2022**

The Coast Guard Foundation strengthens the Coast Guard community by remaining Semper Paratus — *Always Ready*, for members and their families, where and when they need it the most. Thanks to the generosity of our supporters, we met the challenge in all areas of need.

#### **FAMILY RESILIENCE**

We distributed disaster relief grants of up to \$3,000 to 161 Coast Guard members and families impacted by natural disasters last year, including those who lost homes and property to Hurricanes Fiona and Ian.

We expanded tragedy assistance in 2022 to help with unexpected expenses if an active-duty member loses a spouse or dependent child. We pay close attention to the unique needs of the families and Coast Guard members affected, working to provide care and comfort in a supportive, respectful way.

**Ten Coast Guard families received tragedy assistance** after they suffered the death of their Coast Guard members or a child or spouse, providing comfort and solace during their time of great need.

#### **EDUCATION**

We awarded 179 scholarships from \$2,000 to \$5,000 to Coast Guard kids enrolled in college and technical/trade schools, pursuing their degrees. Through the generosity of our supporters, we were able to increase the minimum scholarship amount to a more impactful level and award nine additional scholarships beyond our initial goal.

Six surviving children of Coast Guard members who made the ultimate sacrifice received Fallen Heroes scholarships and education booster grants. Booster grants allow school aged children of the fallen to participate in educational enrichment activities while scholarships cover 100 percent of expenses for those attending the college of their choice. We addressed a wide range of priorities at the Coast Guard Academy, including academic enrichment, cadet activities, athletics, and waterfront activities.

#### WORKFORCE DEVELOPMENT

Workforce development programs provided classes and materials to 232 Coast Guard members pursuing professional certifications, including aircraft maintenance and captains' licenses. This program better prepares them for their Coast Guard missions and their transition into the civilian sector when their service is over. We also awarded 114 grants to Coast Guard members to support their off-duty education.

We awarded Coast Guard spouse grants from \$500 to \$2,000 to 253 Coast Guard spouses pursuing their college degrees and professional certifications. For spouses of military members, achieving higher education or professional licensing and certification boosts the family's financial stability and gives them personal fulfillment

#### MORALE AND WELLNESS

The Foundation funded 252 projects across the country to support morale and wellness at Coast Guard units and help members remain always ready by maintaining their physical and mental well-being while at sea or stationed in remote areas.



We supported life skill resources and activities for Coast Guard families through a partnership with the Coast Guard Chaplain Program, to help families connect and build positive, supportive relationships. We also continued to fund suicide prevention peer training and retreats to build mental resiliency in members and help the Coast Guard address the current military suicide crisis.

The crews of five new fast response cutters brought into service received a grant of \$5,000 to establish their morale and wellness priorities.

#### **COMMUNITY**

**Foundation supporters nationwide raised more than \$31,000** for Fallen Heroes Scholarships and tragedy assistance support for Coast Guard families through Run to Remember events and the Workout to Remember campaign.

We provided 215 grants to Coast Guard kids allowing them to attend virtual and in-person camps and invest in online enrichment activities during summer and school breaks.




