

1.0 **INTRODUCTION**

On November 28, 2012, the Arizona Department of Environmental Quality (ADEQ) requested that HydroGeoLogic, Inc. (HGL) conduct an industrial survey for two areas located within the West Van Buren Area (WVBA) Water Quality Assurance Revolving Fund (WQARF) Registry Site (site) in Phoenix under ADEQ Contract No. EV07-0046, Task Assignment No. 07-0149. This report, which has been revised under ADEQ Contract No. 13-048324, Task Assignment No. 14-055448, provides the findings of the industrial survey. Figure 1.1 depicts the boundaries of the two industrial survey areas (4a and 4b) and the estimated boundaries of the groundwater plume associated with the WVBA WQARF site.¹

The contaminants of concern (COCs) for the WVBA WQARF site include tetrachloroethene (PCE), trichloroethene (TCE), 1,1,1-trichloroethane (1,1,1-TCA), 1,1-dichloroethane (1,1-DCA), cis-1,2-dichloroethene (cis-1,2-DCE), 1,1-dichloroethene (1,1-DCE), and chromium.² The benzene, toluene, ethylbenzene, and xylenes (BTEX) group was once considered a COC because of detections at various locations throughout the plume. However, BTEX was dropped from the COC list because it was limited to leaking underground storage tank (LUST) facilities regulated by the ADEQ Underground Storage Tank (UST) Program. Furthermore, BTEX contamination is limited in extent to an area beneath aboveground storage tanks at the Phoenix Terminal. Releases at the Phoenix Terminal are regulated under the ADEO UST Program and Voluntary Remediation Program [WVDEQP 43776]. In performing the industrial survey, HGL identified businesses located within the industrial survey boundaries that may have used the WQARF site COCs or the other site contaminants identified above. Section 2.0 of this report describes the boundaries for the industrial survey areas; explains HGL's research methodology; and summarizes information pertaining to facilities that were located within the industrial survey areas but were excluded from this industrial survey because they had been investigated previously. Section 3.0 details the results of the industrial survey research. Appendix A provides the results of the city directory research. Appendix B contains a DVD with PDF copies of the source documents used to compile this industrial survey.

Documents obtained during the course of this investigation were assigned an alpha-numeric code corresponding to the source from which they were obtained, and were numbered sequentially within each source. When a document consisted of more than one page, each page



2.0 INDUSTRIAL SURVEY

2.1 IDENTIFICATION OF SITE BOUNDARY

HGL conducted an industrial survey to assist ADEQ in its continuing investigation of the WVBA WQARF site. ADEQ identified two boundaries for the industrial survey area. The first of these areas, Industrial Survey Boundary No. 4a, is bounded by Roosevelt Street to the north, the Union Pacific Railroad tracks to the south, 69th Avenue to the west, and 59th Avenue to the east. The second of these areas, Industrial Survey Boundary No. 4b, is bounded by McDowell Road to the north, Van Buren Road to the south, 51st Avenue to the west, and 43rd Avenue to the east.

HGL used the Maricopa County online geographic information systems mapping program to determine the street address ranges within the industrial survey boundaries. The results were then cross-checked with geographic information systems database information from Arizona State University. Figure 1.1 in Section 1.0 depicts the boundaries of the industrial survey. The street address ranges within the industrial survey boundaries are identified in Table 2.1 below.

2.2 METHODOLOGY

HGL reviewed multiple resources to identify businesses that operated within the industrial survey boundaries. When possible, HGL attempted to ascertain the nature of these businesses. HGL conducted searches of U.S. Environmental Protection Agency (EPA) website databases to locate relevant files regarding the businesses located within the industrial survey boundaries. HGL also contacted the City of Phoenix and Maricopa County to locate files applicable to these businesses. With assistance from ADEQ records management staff, HGL conducted an extensive search of ADEQ databases to locate files pertaining to businesses within the industrial survey boundaries. To locate relevant regulatory files, HGL used the zip codes

Van Buren Street is included in both Industrial Survey Boundaries Nos. 4a and 4b, but both even and odd numbered addresses are included in Industrial Survey Boundary No. 4a and only even addresses are included in Industrial Survey Boundary No. 4b.

85035 and 85043, and the address ranges listed in Table 2.1, to conduct searches. If results were collected for facilities near, but not inside these boundaries, those results were included in the appropriate regulatory records sections if they indicated that the facilities used the WQARF site COCs or other site contaminants, or if the WQARF site COCs or other site contaminants were detected in groundwater or soil samples collected from the facilities. The subsections below describe HGL's research methodology.

2.2.1 City of Phoenix Directory Research

HGL reviewed available Phoenix city directories published by Cole's and Polk's at the Arizona State Capitol Archives Library for the years 1960 to 2013. HGL identified the first commercial entity within the industrial survey boundaries in the 1963 directory. HGL copied the pages of the directories that addressed the street address ranges within the industrial survey boundaries.

HGL identified businesses located within the industrial survey boundaries through the street directory guide portion of the city directories beginning in 2013 and working backward to 1960. Where HGL identified 3 consecutive years of directory results without industrial presence for a particular address range, city directories for that range were only reviewed every 5 years dating back until industry was again identified, at which time HGL returned to conducting searches for that range every year. If the directories did not provide sufficient information to identify the types of operations that a business may have performed, then HGL conducted an Internet search of the company name to obtain additional information. If information identifying the type of operation could not be found through these means, the type of operation was listed as "unidentified" in the city directory results tables included in Appendix A.

Minor variations often occurred in business names over time. HGL assumed that businesses with similar names operating at the same address were the same business and were conducting the same operations. In tables compiled of city directory research, HGL noted the more descriptive name for all years during which the business operated. See Section 3.1 and Appendix A for city directory results.

2.2.2 U.S. Environmental Protection Agency

2.2.2.1 Envirofacts Multi-System Queries Database Files

HGL searched EPA's Envirofacts Multi-System Queries database via the Internet to identify Resource Conservation and Recovery Act (RCRA) facilities. HGL queried the database using the company names identified in Appendix A. A search of the database identified 11 facilities within the industrial survey boundaries that have RCRA identification numbers.

2.2.2.2 Comprehensive Environmental Response, Compensation, and Liability Act Files

HGL searched the EPA Comprehensive Environmental Response, Compensation, and Liability Information System (CERCLIS) database via the Internet to locate Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) sites within the industrial survey boundaries. HGL queried the database by street address and zip code. No sites were identified within the industrial survey boundaries.

2.2.3 Arizona Department of Environmental Quality

2.2.3.1 Resource Conservation and Recovery Act Files

HGL requested that ADEQ search its MegaSearch and AZURITE databases for any RCRA files pertaining to facilities within the industrial survey boundaries. The databases were queried using street addresses. ADEQ identified 33 facilities within the industrial survey boundaries and 2 additional facilities located in close proximity to the industrial survey boundaries with RCRA identification numbers, but no facilities were identified with RCRA files. Additionally, the ADEQ RCRA open and closed case and RCRA compliance log finding aids did not include any files on facilities within the industrial survey boundaries.

2.2.3.2 Preliminary Assessment/Site Inspection Files

HGL requested that ADEQ search its MegaSearch and AZURITE databases for Preliminary Assessment (PA)/Site Inspection (SI) files for facilities within the industrial survey boundaries. The database was queried using street addresses. ADEQ identified two facilities within the industrial survey boundaries with PA/SI files. HGL reviewed and collected documents for these two facilities.

2.2.3.3 Underground Storage Tank/Leaking Underground Storage Tank Files

HGL requested that ADEQ search its MegaSearch and AZURITE databases for UST and LUST files. The databases were queried using street addresses to identify facilities within the industrial survey boundaries. A review of the databases was used to determine if any facilities maintained tanks containing waste oil, used oil, solvents, or an unknown product. HGL also searched the online UST and LUST databases by company name to supplement ADEQ's search. ADEQ and HGL identified 24 facilities with USTs and LUSTs located within the industrial survey boundaries, and 4 facilities with USTs and LUSTs located near, but outside the industrial survey boundaries. HGL reviewed and collected documents for these 28 facilities.

2.2.3.4 Arizona Department of Environmental Quality Water Quality Database Files

HGL did not request that ADEQ conduct a search of its Water Quality Database pursuant to discussions with ADEQ, but HGL did obtain information available in the database such as well location and sampling data through other files at ADEQ.

2.2.3.5 Registered Dry Well Files

HGL requested that ADEQ search its MegaSearch and AZURITE databases to identify registered dry wells within the industrial survey boundaries. The databases were queried using street addresses. Files were identified for 28 facilities within the industrial survey boundaries. Files for these 28 facilities and 83 dry wells within the industrial survey boundaries were reviewed.

2.2.3.6 Water Quality Assurance Revolving Fund Files

HGL requested that ADEQ search its MegaSearch and AZURITE databases by street address to identify WQARF files for facilities located within the industrial survey boundaries. Files

were identified for two facilities located within the industrial survey boundaries, and for one facility located in close proximity to the industrial survey boundaries. HGL reviewed and collected WVBA WQARF files for these three facilities.

2.2.3.7 Septic Tank File Results

HGL requested that ADEQ search for septic tank files for facilities located within the industrial survey boundaries.³ The index sheets were searched using street addresses. A file was identified for one facility located within the industrial survey boundaries. HGL reviewed and collected documents for this one facility.

2.2.3.8 <u>Hazardous Waste Box Storage, Hazardous Materials Incident Logbook, and Hazardous Waste Inspection Files</u>

HGL requested that ADEQ search its MegaSearch and AZURITE databases for hazardous waste box storage, hazardous material incident logbook results, and hazardous waste inspection files for facilities located within the industrial survey boundaries. The databases were queried using street addresses. Files were identified for nine facilities located within the industrial survey boundaries. HGL reviewed and collected documents for these nine facilities.

2.2.3.9 Air Quality Files

HGL requested that ADEQ search its MegaSearch and AZURITE databases for air quality files. The databases were queried using street addresses to identify facilities within the industrial survey boundaries. A review of the databases was used to determine if any facilities had received air quality permits or violations that mentioned the use of the WQARF site COCs or other site contaminants. ADEQ identified three facilities with air quality files located within the industrial survey boundaries. HGL reviewed and collected documents for these three facilities.

2.2.4 Maricopa County

2.2.4.1 Maricopa County Air Quality Department Files HGL submitted a records request to the Maricopa County

HGL submitted a records request to the Maricopa County Air Quality Department for files pertaining to businesses within the industrial survey boundaries. The records request listed street addresses related to the industrial survey boundaries. Maricopa County located files relating to 10 facilities within the industrial survey boundaries. HGL reviewed and collected documents for these 10 facilities.

2.2.5 City of Phoenix

2.2.5.1 City of Phoenix Fire Department Hazardous Materials Incident Files

HGL submitted a records request to the City of Phoenix Fire Department for hazardous materials incident files pertaining to businesses within the industrial survey boundaries. Per direction from ADEQ, HGL's records request listed 33 companies with RCRA identification

numbers that operated at 29 street addresses within the industrial survey boundaries and 2 companies, also with RCRA identification numbers, that operated at 2 addresses located in close proximity to the industrial survey boundaries.⁴ The City of Phoenix Fire Department located files for 71 businesses that operated at the 31 street addresses.⁵ HGL reviewed and collected documents for these 71 businesses. At the request of ADEQ, HGL requested City of Phoenix Fire Department files for an additional four addresses and one intersection associated with companies that are mentioned in Section 4.1 of this report, but that did not have RCRA identification numbers associated with them.⁶ HGL reviewed and collected documents for the four additional addresses. However, it did not review documents associated with the one intersection because the City of Phoenix Fire Department is unable to locate records associated with an intersection [WVFDPX 1059].

2.2.5.2 City of Phoenix Water Services Department – Pollution Control Division Files

HGL submitted a records request to the City of Phoenix Water Services Department -Pollution Control Division for files pertaining to specific businesses within the industrial survey boundaries. HGL provided the names and addresses of the facilities subject to the request. The City of Phoenix Water Services Department - Pollution Control Division located files for two facilities within the industrial survey boundaries, and one facility located outside the industrial survey boundaries. HGL reviewed and collected documents for these three facilities.

2.2.6 HydroGeoLogic, Inc., Water Quality Assurance Revolving Fund Site Files

HGL conducted an electronic search of Arizona WQARF sites files housed at HGL for information on businesses located within the industrial survey boundaries, with the exception of facilities previously investigated (see Table 2.2 below). HGL identified and reviewed files relating to seven facilities.

FACILITIES EXCLUDED FROM INDUSTRIAL SURVEY 2.3

HGL excluded facilities from this industry survey if the facilities had been investigated previously and reports had been issued summarizing the results of these previous investigations. Table 2.2 below lists the facilities located within the industrial survey boundaries but excluded from this report.

HGL previously investigated the facilities listed in Table 2.2 above by reviewing regulatory records to locate documents regarding use and releases of WQARF site COCs and other site contaminants at the facilities. Below is a summary of non-confidential information collected for the facilities during previous investigations.

2.3.1 AT&T Technologies/Belden Communications/Cable Systems, International, Inc. (505 North 51st Avenue)

On March 29, 2004, HGL issued a letter report to ADEQ for AT&T Technologies, located at 505 North 51st Avenue. The letter report also addresses Belden Communications and Cable Systems International, Inc., because they operated at 505 North 51st Avenue.⁷ According to a November 2, 1992, SI report prepared by ADEQ, the COCs 1,1-DCE, 1,1-DCA, 1,1,1-TCA, TCE, and PCE were detected in soil and soil gas samples at the facility. The COC chromium was also detected in soil samples at the facility. According to this same report, AT&T generated the following hazardous wastes: 1,1,1-TCA, methyl ethyl ketone, sulfuric acid and sodium hydroxide from the water treatment process, and laboratory waste containing inorganic waste (acids) [WVDEQP 7567, 7574, 7579-7580].

2.3.2 Dolphin, Inc. (740 South 59th Avenue)

In February 2012, HGL issued a report to ADEQ regarding the Dolphin, Inc., facility located at 740 South 59th Avenue. According to a 1993 hazardous waste report prepared by EPA, the COCs PCE, chromium, and 1,1,1-TCA were used at the facility [WVDEQI 6826-6846]. Additionally, since 1992, several investigations of soil, soil vapor, and groundwater have been conducted at the Dolphin, Inc., facility. COCs detected in these investigations include PCE, TCE, 1,1-DCE, *cis*-1,2-DCE, 1,1,1-TCA, and chromium. PCE has been found in greater concentrations than other COCs [WVDEQP 13-15, 7865].

2.3.3 Joe's Diesel Repair (6316 West Van Buren Street)

On April 8, 2004, HGL issued a letter report to ADEQ for Joe's Diesel Repair, also known as Western Diesel Repair, located at 6316 West Van Buren Street. A July 1989 Phase I report prepared by Kleinfelder, Inc., states that TCE and 1,1,1-TCA had been found in soil at the Joe's Diesel Repair facility. The report recommended the facility for an SI or physical testing, and stated that further activities were planned for Joe's Diesel Repair. These planned activities included sending out a questionnaire and conducting further research of regulatory records. An October 12, 1989, hazardous materials questionnaire completed by the owners of the property where Joe's Diesel Repair had formerly operated indicates that no release had occurred on site. The hazardous materials used on the property were diesel, motor oil, and gasoline [WVDEQI 1701-1705, 10278-10386].

2.3.4 Maximet Corporation (5925 West Monroe Street)

On December 23, 2003, HGL issued a letter report to ADEQ for the Maximet Corporation facility at 5925 West Monroe Street. A toxic release inventory produced on October 2, 2000, indicates that Maximet Corporation released 1,1,1-TCA into the air from 1989 to 1992 [WVDEQI 9861-9865]. Although TCE, 1,1,1-TCA, PCE, 1,1-DCE, and 1,1-DCA were among the chemicals found at a petroleum storage tank farm near Maximet Corporation, a June 4, 1992, report determined that this information was insufficient to attribute contamination in the groundwater to Maximet Corporation and EPA recommended no further remedial action at the facility [WVDEQP 17890-17892].

2.3.5 Petco, Inc. (304 South 67th Avenue)

On March 29, 2004, HGL issued a letter report to ADEQ for Petco, Inc., located at 304 South 67th Avenue. A July 1989 Phase I report prepared by Kleinfelder, Inc., states that TCE and 1,1,1-TCA had been found at the Petco, Inc., facility [WVDEQI 10281-10386]. In a December 18, 1989, ADEQ interoffice memorandum regarding an August 4, 1988, hazardous waste inspection, it was noted that the ADEQ Hazardous Waste Inspection Unit had taken a sample of the sludge and liquid contained in the wash pit at the facility and that it had contained PCE. The amount of PCE detected was determined to be too low to be quantified by the laboratory [WVDEQP 57760].

2.3.6 Salesco Systems USA (5736 and 5752 West Jefferson Street)

On November 22, 2006, HGL issued a letter report to ADEQ for Salesco Systems USA, located at 5736 and 5752 West Jefferson Street, which included documentation found regarding the use and presence of the COCs. According to a January 21, 1992, letter from Edward Nemecek of Harding Lawson Associates to ADEQ, 1,1-DCA, 1,1-DCE, and PCE were detected in sludge samples taken at the 5736 West Jefferson Street facility. A January 28, 1992, record of a telephone conversation between Tom Curry of ADEQ and David Williams of Lockheed Corp., indicates that the "property owner" was under investigation for BTEX contamination in a dry well. On August 8, 1994, ADEQ informed Salesco Systems USA that no further investigations of the 5752 West Jefferson Street property would be initiated under the WQARF program, as ADEQ had not found any evidence of a release or threatened release at the property [WVDEQP 57761-57765].

3.0 INDUSTRIAL SURVEY RESULTS

3.1 CITY OF PHOENIX DIRECTORY RESULTS

In conducting Phoenix city directory research on the 56 address ranges located within the industrial survey boundaries, HGL assigned each of the businesses to a general business category when the appropriate business category could be determined. Under a previous task assignment for ADEQ, HGL identified general business categories associated with the use or generation of WQARF site COCs and other site contaminants. HGL used this research to eliminate from this industrial survey the companies that were unlikely to have used the WVBA WQARF site COCs or other site contaminants. In total, the business categories that may have used or generated WQARF site COCs or other site contaminants include 670 businesses within the industrial survey boundaries. The business activities of the other 135 businesses could not be readily determined and, as a result, the businesses are also listed in Appendix A.

Appendix A presents the results of the Phoenix city directory research by street address for those facilities suspected of possibly using or generating the WQARF site COCs or other site contaminants, and those facilities for which the business activities could not be readily determined. The tables included in Appendix A list the street address, business name, years of operation, and business type, if known. The business names and years of operation are provided as listed in the Phoenix city directories. Business types were identified based on city directory listings or by business name. If a business type could not be determined, the business type is listed as "undetermined."

3.2 U.S. ENVIRONMENTAL PROTECTION AGENCY

3.2.1 U.S. Envirofacts Multi-System Queries Database File Results

A search of the EPA Envirofacts Multi-System Queries database identified 11 companies within the industrial survey boundaries that have RCRA identification numbers [WVEPAW 8-25]. Table 3.1 below identifies 9 of the 11 companies.⁹

3.2.2 Comprehensive Environmental Response, Compensation, and Liability Act File Results

A search of the EPA CERCLIS database did not identify any CERCLA sites within the industrial survey boundaries.

3.3 ARIZONA DEPARTMENT OF ENVIRONMENTAL QUALITY

3.3.1 Resource Conservation and Recovery Act File Results

A search of ADEQ's MegaSearch and AZURITE databases identified 33 companies within the industrial survey boundaries and 2 companies located in close proximity to the industrial survey boundaries that have RCRA identification numbers. Table 3.2 below identifies 33 of the 35 companies. 10 However, no RCRA files were found for facilities within the industrial survey boundaries.

Additionally, the ADEQ RCRA open and closed case and RCRA compliance log finding aids did not include any files on facilities within the industrial survey boundaries.

3.3.2 Preliminary Assessment/Site Inspection File Results

PA/SI files were identified for two facilities within the industrial survey boundaries: AT&T Technologies, 505 North 51st Avenue; and Maximet Corporation, 5925 West Monroe Street. File results for AT&T Technologies and Maximet Corporation are excluded from this report because the facilities were investigated previously. See Section 2.3 for a summary of information found on these facilities and previously presented to ADEQ in letter reports.

3.3.3 Underground Storage Tank/Leaking Underground Storage Tank Files Results

A search of the ADEQ MegaSearch, AZURITE, and online UST and LUST databases identified UST and LUST files for 28 facilities, 24 located within the industrial survey boundaries and 4 located near, but outside of the industrial survey boundaries. Table 3.3 identifies the facilities that had USTs and LUSTs and includes the size of each tank. Figure 3.1 is a map of the UST and LUST facilities within or near the industrial survey boundaries. Companies with positive results for WQARF site COCs or other site contaminants are described in more detail in Sections 3.3.3.1 to 3.3.3.4 below. Additionally, Section 3.3.3.5 discusses a company for which soil sampling results were not found in the file.



3.3.3.1 7-Eleven, Inc. Store No. 22631 (5050 West McDowell Road)

7-Eleven Store No. 22631, located at 5050 West McDowell Road, installed three 12,000-gallon gasoline USTs and one 12,000-gallon diesel UST in 1978. These tanks were subsequently decommissioned and excavated on April 25, 2000 [WVDEQP 43276, 43565, 43593]. Results from a November 11, 1993, soil sampling event confirmed the suspected release of unleaded gasoline near a fuel delivery line at the facility [WVDEQP 43276]. Detections above groundwater protection levels (GPLs) and/or soil remediation levels (SRLs) from the 1993 soil sampling event are provided in Table 3.4 below.

From April 5 through 9, 1999, IT Corporation drilled four soil borings at the 5050 West McDowell Road facility on behalf of 7-Eleven. Soil samples collected from the soil borings were analyzed for total petroleum hydrocarbons (TPH) and BTEX. Table 3.4 below includes concentrations for TPH and BTEX in samples collected from soil borings at the facility in 1993, 1997, 1999, and 2008.

Since petroleum hydrocarbons were encountered in soil samples collected from April 5 to April 9, 1999, a groundwater monitoring well was installed on April 9, 1999, and was sampled on April 22, 1999. Analytical results from this sampling indicate that the sample contained concentrations of benzene and TCE above applicable Aquifer Water Quality Standard (AWQS) limits at 342 micrograms per liter (μ g/L) and 10 μ g/L, respectively. ¹⁵ A second sampling conducted on May 27, 1999, to confirm these results identified benzene at a concentration of 961 μ g/L and toluene at a concentration of 1,960 μ g/L. ¹⁶ Three more groundwater monitoring wells were installed at the facility from November 8 through 11, 1999. On December 9, 1999, all four groundwater monitoring wells were sampled. Benzene was detected above the AWQS limit of 5 μ g/L at concentrations ranging from 32 μ g/L to 520 μ g/L. Toluene was detected at a concentration of 1,000 μ g/L, which is equivalent to its respective AWQS limit. Ethylbenzene and xylenes were not detected above AWQS limits, and the samples were not analyzed for other analytes [WVDEQP 43154, 43279-43281, 43285-43286].

In 2011, soil samples were collected from one of the monitoring wells. The samples were not analyzed for TPH. Benzene was detected at a concentration as high as 4.27 milligrams per kilogram (mg/kg) at a depth of 50 feet, toluene was detected at a concentration as high as 709 mg/kg at a depth of 50 feet, ethylbenzene was detected at a concentration as high as 303 mg/kg at a depth of 50 feet, and total xylenes was detected at a concentration as high as 1,850 mg/kg at a depth of 50 feet [WVDEQP 43180-43182].¹⁷

Groundwater sampling was conducted at the 7-Eleven facility from 2000 to 2013. Table 3.5 below includes concentration ranges above the AWQS limits for BTEX in groundwater samples collected at the facility, and identifies the wells with which those ranges are associated. A figure depicting the locations of these wells is included as Figure 3.2.

The AWQS limits for benzene and toluene are 5 μ g/L and 1,000 μ g/L, respectively [GDASOS 10, 12].



3.3.3.2 Circle K Stores, Inc. No. 0608 (6440 West Van Buren Street)

Circle K Store No. 0608, located at 6440 West Van Buren Street, installed two 10,000-gallon gasoline USTs and one 6,000-gallon gasoline UST on April 4, 1974 [WVDEQP 43409]. According to an October 1993 Phase II Subsurface Assessment, a release from a premium unleaded product line near the east pump island was reported on December 4, 1992, and the system was subsequently "taken out of service." The two remaining UST systems were "taken out of service" in July 1993 [WVDEQP 43362]. 18

Results from soil sampling conducted in 1993 indicated benzene concentrations of 29 to 440 micrograms per kilogram ($\mu g/kg$), toluene concentrations of 32 to 77,000 $\mu g/kg$, ethylbenzene concentrations of 42 to 53,000 $\mu g/kg$, total xylenes concentrations of 45 to 370,000 $\mu g/kg$, and TPH concentrations of 80,000 to 1,500,000 $\mu g/kg$ [WVDEQP 43370-43371].¹⁹

Groundwater sampling was conducted at the Circle K Store No. 0608 from 1998 to 2000. ²⁰ Table 3.6 below includes concentration ranges above GPLs and SRLs for volatile organic compounds (VOCs) and BTEX in groundwater samples collected at the facility, and identifies the wells with which those ranges are associated. A figure depicting the location of these wells is included as Figure 3.3.

3.3.3.3 Fry's Food Stores of Arizona, Inc./Kroger Company (6101 West Washington Street)

Fry's/Kroger, located at 6101 West Washington Street, installed two 10,000-gallon diesel USTs, one 12,000-gallon diesel UST, and one 550-gallon waste oil UST in June 1975 [WVDEQP 42911, 42923, 42932]. All four USTs were decommissioned and removed on October 19, 1999 [WVDEQP 42926]. According to a November 1999 ADEQ notification of USTs form, Tank 2, a 10,000-gallon diesel UST, had evidence of a leak [WVDEQP 42926]. Soil sampling results analyzed on November 8, 2000, defined the extent of soil contamination to a depth of 20 feet below ground surface [WVDEQP 42876].

Results from groundwater sampling taken on June 27, 2001, indicated concentrations of PCE exceeding the AWQS limit of 5 μ g/L with a concentration of 18 μ g/L [WVDEQP 42881]. On June 19, 2007, ADEQ approved closure of the 10,000-gallon diesel fuel UST and diesel fuel dispenser island, citing COC concentrations below applicable AWQS limits for groundwater and SRLs for soil [WVDEQP 42876-42877].

3.3.3.4 KAG West, LLC/Beneto Tank Lines, Inc. (6035 West Washington Street)

KAG West, LLC/Beneto Tank Lines, Inc., located at 6035 West Washington Street, installed one 10,000-gallon diesel UST in September 1986 and one 1,000-gallon used oil UST in January 1987 [WVDEQP 42591, 42674]. In 1999, the 1,000-gallon used oil UST was decommissioned and removed [WVDEQP 42667]. Soil sampling was conducted in February 1999. There were no detections of benzene, 1,1-DCE, *cis*-1,2-DCE, TCE, PCE, or 1,1,1-TCA in the soil samples. Additionally, soil sample results were below GPLs and SRLs for toluene, xylenes, and ethylbenzene [GDDEQW 10-12, 13-29; WVDEQP 42696-42713].²¹

3.3.3.5 Southwest Freeport/The RREEF Funds (431 North 47th Avenue)

Southwest Freeport/The RREEF Funds, located at 431 North 47th Avenue, installed two 10,000-gallon diesel USTs in 1986 and subsequently decommissioned and removed both tanks on October 14, 1992 [WVDEQP 42962-42963]. Comments on the 1992 notification of USTs form indicate that test results of soil samples taken from the surface of the excavation areas indicated that the USTs and fuel lines had not leaked. However, analysis of a soil sample taken on an unknown date from beneath the fuel dispenser indicated that the dispenser had had a release of diesel fuel [WVDEQP 42965].²² No other documentation indicating a release exists in the files.

3.3.4 Registered Dry Well File Results

A search of the ADEQ MegaSearch and AZURITE databases identified 36 facilities within the industrial survey boundaries with registered dry wells. Table 3.7 below identifies these facilities, which are discussed in more detail in Sections 3.3.4.1 to 3.3.4.25 below.²³

3.3.4.1 Auto Shack (4741 West Polk Street)

Auto Shack filed a registration form for six stormwater dry wells on October 5, 1988. The dry wells received registration numbers 07-002149-03 through 07-002154-03. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, landscaped areas, and loading docks.²⁴ Auto Shack stated that no liquids, solvents, or other

chemicals were used or stored at its facility. Dry Wells 1 through 3 were completed on September 19, 1988, and Dry Wells 4 through 6 were completed in approximately 1983. The nature of the business was listed as warehouse [WVDEQP 50150-50154].

3.3.4.2 B&R Building (125 North 67th Avenue)

B&R Building filed a registration form for four industrial and stormwater dry wells on October 8, 2001. The dry wells received registration numbers 07-22647-03 through 07-22650-

03. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, and loading docks not containing hazardous materials. The nature of the business was listed as general warehouse [WVDEQP 50155-50156].

3.3.4.3 Beneto Tank Lines, Inc. (6045 West Washington Street)

Beneto Tank Lines, Inc. filed a registration form for one industrial and stormwater dry well on May 13, 1998. ²⁵ The dry well received registration number 07-15878-10. According to the dry well registration form, the purpose of the dry well was to drain driveways, parking lots, rooftops, streets, and loading docks for general use and for the transport of hazardous substances. The nature of the business was listed as warehouse, vehicular and service facilities, with Standard Industrial Classifications (SIC) codes 4226 and 4231 [WVDEQP 50292-50294]. ²⁶

Beneto Tank Lines, Inc., filed an aquifer protection permit determination of applicability for one industrial and stormwater dry well on September 5, 1998. According to the form, facility operations included fuel storage greater than 55 gallons and truck or car washing. Beneto Tank Lines, Inc., stated that the dry well did not drain any areas where hazardous substances were used, stored, loaded, or treated, nor did the dry well receive unauthorized discharges. Construction of the dry well was completed on May 13, 1998 [WVDEQP 50277-50280].

3.3.4.4 City of Phoenix (69th Avenue from Farmer Road to West Van Buren Street)

The City of Phoenix filed a registration form for one industrial and stormwater dry well on November 5, 1998. The dry well received registration number 07-16930-10. The nature of the business was listed as public right-of-way [WVDEQP 49810-49811].

3.3.4.5 **D.S.O.** Leasing (125 North 61st Avenue)

D.S.O. Leasing filed a registration form for one industrial and stormwater dry well on December 3, 2002. The dry well received registration number 07-26075-02. According to the

dry well registration form, the purpose of the dry well was to drain driveways and parking lots. The nature of the business was listed as general non-chemical handling warehouse [WVDEQP 50546-50548].

3.3.4.6 First Commons (4537 West McDowell Road)

First Commons filed a registration form for one industrial and stormwater dry well on January 1, 2000.²⁷ The dry well received registration number 07-19015-02. According to the dry well registration form, the purpose of the dry well was to drain driveways, parking lots, rooftops, streets, landscaped areas, and general use loading docks. The nature of the business was listed as offices and retail only [WVDEQP 50317-50320].

3.3.4.7 G&K Services, Inc. (4804 West Roosevelt Street)

On March 4, 2001, G&K Services, Inc. filed a notice of intent (NOI) to discharge for a Type 2 general permit form. G&K Services, Inc., applied for a Type 2.01 permit, which includes dry wells that drain areas where hazardous substances are used, stored, loaded, or treated. The dry well received inventory number 106248, licensing time frame number 53965, and registration number 13297. The dry well was installed in 1996. Per permit requirements, it was installed 100 feet or more away from a water supply well and 20 feet or more from a UST [WVDEQP 50324-50328]. Also per permit requirements, the "grate or manhole cover" of the dry well was marked "Stormwater Only" [WVDEQP 50325-50326].

Results from an April 14, 2009, soil sampling event detected chromium at concentrations of up to 31 mg/kg in DW-1-35, below the GPL of 590 mg/kg. Other WQARF site COCs were not detected above the minimum laboratory detection limits [WVDEQP 55879-55883].

According to a December 9, 2010, final summary report of findings prepared by URS, there were indications that the well had received discharges other than stormwater. However, according to the 2011 NOI supplement for a Type 2.01 general permit, the dry well was not receiving discharges other than stormwater [WVDEQP 50322-50345]. G&K Services, Inc., noted on the NOI supplement that no SRLs or GPLs had been exceeded in sampling results [WVDEQP 50324, 50326, 50338-50339].

On November 16, 2011, G&K Services, Inc., filed an NOI to discharge relating to a dry well located at the 4804 West Roosevelt Street facility. According to the form, the dry well met all the requirements for the permit [WVDEQP 55842, 55844].

3.3.4.8 G.I. Trucking (5939 West Washington Street)

G.I. Trucking filed a registration form for three dry wells on December 16, 1993. The dry wells received registration numbers 07-008993-08 through 07-008995-08. According to the dry well registration form, the purpose of all three dry wells was to drain driveways, parking lots, and rooftops. Dry Well 1 also was used to drain a chemical fuel storage and vehicular servicing area. Dry Well 2 also was used to drain a vehicular servicing area. G.I. Trucking

stated on the registration form that diesel fuel and motor oil were being used or stored at its facility. The nature of the business was listed as warehouse, chemical and fuel storage, and vehicular service [WVDEQP 50346-50351].

3.3.4.9 Goodyear Building (4501 West Polk Street)

The Globe Corporation, the owner of the Goodyear Building, filed a registration form for two stormwater dry wells on the property on March 5, 1990. The dry wells received registration numbers 07-003524-03 through 07-003525-03. According to the dry well registration form, the dry wells were to drain driveways, parking lots, rooftops, and loading docks. The form indicates that that no liquids, solvents, or other chemicals were being used or stored at the warehouse facility. Construction of the dry wells was completed in September 1984, prior to the Globe Corporation's purchase of the Goodyear Building property on February 9, 1990 [WVDEQP 50353-50356].

3.3.4.10 <u>Imagineering/Creative Images, Inc./Office/Warehouse (6025 West Van Buren Street)</u>

Imagineering/Creative Images, Inc., filed a registration form for two dry wells on June 25, 1990.²⁸ The dry wells received registration numbers 07-003695-04 through 07-003696-04. According to the dry well registration form, the purpose of both dry wells was to drain driveways, parking lots, and streets. Dry Well 1 also was used to drain loading docks. Construction of the dry wells was completed in 1986. Imagineering/Creative Images, Inc., stated that no liquids, solvents, or other chemicals were used or stored at its facility. The nature of the business was listed as warehouse and manufacturing [WVDEQP 50357-50360].

On April 16, 1997, Samuel J. and Maxine M. Jones filed a registration form for three additional stormwater dry wells at the property identified as an "office/warehouse." The dry wells received registration numbers 07-013801-03 through 07-13803-03. According to the dry well registration form, the purpose of the three dry wells was to drain driveways, parking lots, rooftops, and streets. Dry Wells 1 and 2 also were used to drain landscaped areas and Dry Well 3 also was used to drain general use loading docks. The nature of the business was listed as warehouse [WVDEOP 50429-50431].

3.3.4.11 Ingram Paper Co. (430 North 47th Avenue)

Ingram Paper Co. filed a registration form for three dry wells on June 14, 1988. The dry wells received registration numbers 07-001734-04 through 0701736-04. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, rooftops, and streets. Dry Well 3 also was used to drain landscaped areas. The nature of the business was listed as warehouse and manufacturing [WVDEQP 50361-50363].

3.3.4.12 Mack Papago Warehouse, Lot 3/Unisource Worldwide (844 North 44th Avenue)

Mack Papago Warehouse, Lot 3, filed an aquifer protection permit determination of applicability for dry wells on April 2, 1997. According to the form, the facility was vacant at the time. The nature of the business was listed as warehouse. Facility operations were not further described, but the form states that dry wells would not be used for the storage, loading, or treatment of hazardous substances [WVDEQP 50370-50373].

Mack Papago Warehouse, Lot 3, filed a dry well registration form for two stormwater dry wells on January 28, 1998.³⁰ The dry wells received registration numbers 07-15337-03 through 07-15338-03 [WVDEQP 50364-50365]. Mack Papago Warehouse, Lot 3, filed an additional dry well registration form for a third stormwater dry well on March 5, 1998 [WVDEQP 50366-50367]. According to the dry well registration forms, the purpose of the dry wells was to drain driveways, parking lots, rooftops, streets, and landscaped areas. The nature of the business was listed as warehouse [WVDEQP 50364-50369].

On December 11, 1998, at this same address, Unisource Worldwide filed a dry well registration form for six stormwater dry wells.³¹ The dry wells received registration numbers 07-17069-10 through 07-17074-10. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, and rooftops. The nature of the business was listed as general warehouse, office, and distribution [WVDEQP 50554-50555].

3.3.4.13 Metal Form Manufacturing (5960 West Washington Street)

Metal Form Manufacturing filed a registration form for two dry wells on September 2, 1992.³² The dry wells received registration numbers 07-006877-04 and 07-006878-04. According to the dry well registration form, the purpose of Dry Well 1 was to drain driveways, parking lots, and loading docks. The purpose of Dry Well 2 was to drain rooftops and landscaped areas. Construction of the dry wells was completed on November 25 and 26, 1991. The nature of the business was listed as manufacturing [WVDEQP 50410-50412].

3.3.4.14 Multi-Tenant Commercial Center (402 North 44th Avenue)

Multi-Tenant Commercial Center filed a registration form for four industrial and stormwater dry wells on October 8, 2001.³³ The dry wells received registration numbers 07-22647-03 through 07-22650-03. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, and loading docks not containing hazardous materials. The nature of the business was listed as general warehouse [WVDEQP 50155-50156].

3.3.4.15 Papago Distribution Center/USPS Phoenix PMPPC (620 North 47th Avenue)

Papago Distribution Center filed a registration form for three dry wells on June 26, 2003. ³⁴ The dry wells received registration numbers 07-26372-03 through 076374-03. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, rooftops, streets, landscaped areas, and loading docks where no hazardous materials were handled. The nature of the business was listed as general non-chemical handling warehouse and "USPS" [WVDEQP 50436-50439].

On July 14, 2004, USPS Phoenix PMPPC filed a dry well registration form for three additional dry wells.³⁵ The dry wells received registration numbers 07-26372-03 through 26374. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, and rooftops. The nature of the business was listed as U.S. Post Office [WVDEQP 50561-50562].

3.3.4.16 Papago Industrial Park (302 North 45th Avenue)

Papago Industrial Park filed a registration form for one stormwater dry well on May 28, 1997. The dry well received registration number 07-014016-03.³⁶ According to the dry well registration form, the purpose of the dry well was to drain driveways, parking lots, rooftops, and streets. The nature of the business was listed as warehouse [WVDEQP 50446-50448].

On March 12, 1999, Papago Industrial Park filed another dry well registration form for one stormwater dry well. The dry well received registration number 07-17638-03. According to the registration form, the purpose of the dry well was to drain driveways, parking lots, rooftops, and streets. The nature of the business was listed as warehouse [WVDEQP 50440-50442].

3.3.4.17 Papago West (43rd Avenue and Roosevelt Street)

Papago West filed a registration form for four stormwater dry wells on October 26, 1995.³⁷ The dry wells received registration numbers 07-011679-04 through 07-011682-04. According to the form, the purpose of the dry wells was to drain driveways, parking lots, rooftops, and streets. The nature of the business was listed as warehouse and manufacturing [WVDEQP 50449-50451].

3.3.4.18 RJB Development Phase III (4405 West Roosevelt Road)

RJB Development Phase III filed a registration form for six industrial and stormwater dry wells on May 23, 2000.³⁸ The dry wells received registration numbers 07-19506-03 through 07-19511-03. According to the dry well registration form, the purpose of the dry wells was to drain driveways, parking lots, rooftops, streets, and landscaped areas. The nature of the business was listed as general warehouse [WVDEQP 50528-50530].

3.3.4.19 RJB Warehouse Phase III (4411 West Roosevelt Street)

RJB Warehouse Phase III filed a registration form for five industrial and stormwater dry wells on December 22, 1998.³⁹ The dry wells received registration numbers 07-17628-03 through 07-17632-03. According to the registration form, the purpose of Dry Wells 1 through 3 was to drain driveways, parking lots, rooftops, landscaped areas, and general use loading docks. The purpose of Dry Wells 4 and 5 was to drain rooftops and landscaped areas. The nature of the business was listed as warehouse [WVDEQP 50531-50532].

3.3.4.20 Sharon Stair System (6029 West Washington Street)

Sharon Stair System filed a registration form for one industrial and stormwater dry well on July 31, 1991.⁴⁰ The dry well received registration number 07-004242-04. According to the registration form, the purpose of the dry well was to drain driveways, parking lots, and landscaped areas. Sharon Stair System stated that the dry well did not drain any fluids other than stormwater. Construction of the dry well was completed on September 26, 1988. The nature of the business was listed as manufacturing [WVDEQP 50533-50537].

3.3.4.21 Smart & Final (1450 North 43rd Avenue)

Smart & Final filed a registration form for one stormwater dry well on December 9, 2003. The dry well received registration number 07-27501-02.⁴¹ According to the registration form, the purpose of the dry well was to drain driveways or parking lots, rooftops, streets or landscaped areas, and loading docks where no hazardous materials were handled. The nature of the business was listed as offices and retail only [WVDEQP 50538-50539].

3.3.4.22 Southwest Freeport Warehouse (431 North 47th Avenue)

Southwest Freeport Warehouse filed a registration form for one stormwater dry well on January 8, 1996. 42 The dry well received registration number 07-011939-03. According to the form, the purpose of the dry well was to drain driveways and parking lots. The nature of the business was listed as food grade warehouse and distribution center [WVDEQP 50543-50545].

3.3.4.23 Southwest Regional Council of Carpenters (45th Avenue and McDowell Road)

Southwest Regional Council of Carpenters filed a dry well registration form for one dry well on May 7, 2003. The dry well received registration number 07-26075-02. According to the dry well registration form, the purpose of the dry well was to drain driveways, parking lots, rooftops, streets, and landscaped areas. The nature of the business was listed as offices and retail only [WVDEQP 50546-50548].

3.3.4.24 ValWest Technologies, Inc. (430 North 47th Avenue)

ValWest Technologies, Inc., filed a dry well registration form for six dry wells on September 13, 2004. The dry wells received registration numbers 07-29098-04 through 07-29103-04. According to the dry well registration form, the purposes of the six dry wells were as follows: Dry Well 1 was to drain rooftops, Dry Wells 2 and 5 were to drain streets or landscaped areas, Dry Wells 3 and 4 were to drain driveways or parking lots and loading docks where no hazardous materials were handled, and Dry Well 6 was to drain driveways or parking lots. ValWest Technologies, Inc., stated that the dry wells did not drain any areas where hazardous substances were used, stored, loaded, or treated. The nature of the business was listed as manufacturing engineering [WVDEQP 50567-50569].

3.3.4.25 Warehouse Facility (4801 West Polk Street)

A warehouse facility filed a registration form for nine industrial and stormwater dry wells that was approved on February 19, 1999. ^{43,44} The dry wells received registration numbers 07-17397-03 through 07-17405-03. According to the dry well registration form, the purpose of the nine dry wells was to drain driveways, parking lots, and rooftops. Dry Wells 4 through 7 also were used to drain streets and landscaped areas, and Dry Wells 1 through 7 were also used to drain general use loading docks. The nature of the business was listed as warehouse and offices and retail only [WVDEQP 50570-50572].

3.3.5 Water Quality Assurance Revolving Fund File Results

The ADEQ MegaSearch and AZURITE databases listed the following two WQARF files for companies located within the industrial survey boundaries: AT&T, 505 North 51st Avenue; and Salesco Systems Arizona Plant, 5736 and 5752 West Jefferson Street. The files for AT&T and Salesco Systems Arizona Plant were not collected because research was previously conducted on these companies. See Section 2.3 for a summary of information found on these facilities. A third WQARF file was obtained for Arizona Meadows, located one block south of Industrial Survey Boundary No. 4a, at 67th Avenue and Durango Road. This file was collected and is summarized below.

3.3.5.1 Arizona Meadows (67th Avenue and Durango Road)

Arizona Meadows removed six USTs containing gasoline and diesel fuel in February 1999. A petroleum tank leak was confirmed when the USTs were removed. Soil contamination extended to groundwater at 77 feet below ground surface. Groundwater samples were taken from a monitoring well and two soil borings on April 19 and April 20, 2000. Benzene, toluene, and total xylenes were detected above their respective AWQS limits in MW1. Benzene was detected in MW1 at a maximum concentration of 310 μ g/L, toluene was detected at a concentration of 1,200 μ g/L, and total xylenes were detected at a concentration of 1,300 μ g/L. On April 25, 2000, three monitoring wells, including MW1, were sampled for BTEX. The only WQARF site contaminant detected above its AWQS limit was benzene, which was detected at a concentration of 150 μ g/L in MW-1 [WVDEQP 50418-50419].

Arizona Meadows entered into the ADEQ Voluntary Remediation Program on November 16, 2001, and an area of contaminated soil approximately 200 by 110 feet in size was excavated. The contaminants in the soil were TPH and BTEX. According to the WQARF site screening form, the residential SRLs and GPLs for benzene were exceeded in the soil samples. 49 Contaminated soil was removed and confirmation sampling was performed on the walls and bottom of the excavation pit to confirm that levels of the contaminants were below their respective residential SRLs and GPLs. On March 10, 2003, ADEQ notified the property owner that no further action was required for soil [WVDEQP 50418].

On March 11, 2003, the ADEQ Voluntary Remediation Program concluded that "[t]he groundwater portion of this site should be referred to the Site Assessment Unit for possible additional investigation," citing April 2000 groundwater sampling results [WVDEQP 50423-50425]. An October 23, 2003, WQARF site screening form indicates that no further action was required under WQARF because all USTs had been removed, contaminated soil had been remediated, no people were drinking the contaminated water, and the contamination did not extend beyond the boundaries of Arizona Meadows [WVDEQP 50415, 50421]. According to the WQARF site screening form, the approximately 68-acre property had historically been used as a family-owned dairy operation and an agricultural facility dating back to 1910. As of January 2002, five abandoned residences, two equipment storage canopies, and a silo occupied approximately 9 acres along the northern part of the property, which was the area where the six USTs containing gasoline fuel and diesel had been located. As of October 23, 2003, the property was under residential development [WVDEQP 50419-50420].

3.3.6 Septic Tank Files Results

ADEQ found a septic tank file for one facility, Modern Component Systems, located within the industrial survey boundaries.

3.3.6.1 Modern Component Systems (6323 West Van Buren Street)

Modern Component Systems filed an individual sewage disposal system permit application for a 750-gallon concrete septic tank on May 22, 1981. The septic tank received permit number 81-0994. The maximum number of users listed was eight [WVDEQP 50374-50377].

3.3.7 Hazardous Waste Box Storage, Hazardous Materials Incident Logbook, and Hazardous Waste Inspections Files Results

The ADEQ MegaSearch and AZURITE databases listed hazardous waste box storage files for G&K Services, Inc., and hazardous materials incident logbook files for the following nine facilities within the industrial survey boundaries: Bill Birmingham, DNS Trucking, Fowler School, G.I. Trucking, Nalco Chemical, South Western Ice, an Unknown/City of Phoenix facility, and two unknown facilities. ⁵⁰ None of the files for these facilities indicated the use of WQARF site COCs or other site contaminants. ⁵¹

3.3.7.1 Bill Birmingham (950 North 67th Avenue)

A hazardous materials incident report was filed on June 9, 1989, by an anonymous party for an unknown quantity of spilled diesel fuel. Bill Birmingham, located at 6403 West McDowell Road, reportedly was the responsible party. The incident received report number 475.763. The report lists the cause of the incident as follows: "After the irrigation waters within 50 [feet] of [the] tank evaporate, a black/dark stain is on the soil" [WVDEQP 50298]. The anonymous party stated that the property had a tank with a dispenser pump near it, and the soil from within 50 feet of the tank yielded a greasy layer when put into water [WVDEQP 50298]. ⁵²

3.3.7.2 DNS Trucking (Interstate 10 and 43rd Avenue)

An Emergency Response Notification System (ERNS) incident notification report was filed on August 9, 1998, for the discharge of 100 gallons of diesel fuel from a ruptured 300-gallon DNS Trucking fuel tank on Interstate 10 at 43rd Avenue. The incident received Emergency Response Unit (ERU) number 93-046-A. The report states that the City of Phoenix Fire Department treated the spill with dispersant and washed the treated fuel into drains leading to Arizona Department of Transportation sumps for recovery [WVDEQP 50300].

3.3.7.3 Fowler School (67th Avenue and West Van Buren Street)

A hazardous materials incident report form was filed on November 8, 1988, for the discharge of 25 milliliters of an unknown organophosphate (suspected to be malathion) into the boys' restroom at the Fowler School. The cause of the incident was vandalism. The incident received incident number 88-353. Control efforts included instructing the principal of the school to have the bathroom washed down with 5 gallons of bleach, to let it stand for 1 hour,

rinse it with soap and water, allow it to dry, and repeat the process as necessary until the odor disappeared. The restroom was to remain closed until the cleanup was complete. The incident report stated that an "Easy Tech" test showed positive results for pesticides and that a "Haz Cat" test was positive for organophosphates [WVDEQP 50321].

3.3.7.4 G.I. Trucking (5939 West Washington Street)

An incident report from the Arizona Department of Health Services, Division of Environmental Health, was filed for a fire possibly caused by oxidizer, rain, and organic matter in a dumpster at G.I. Trucking on July 27, 1987. The incident received report number 87-161. According to the report, the material involved consisted of an unknown quantity of oxidizer (solid chlorine) and empty propane containers (small torch).⁵³ Control efforts included letting the fire burn to consume the solid chlorine. Comments on the report indicate that there was no discoloration in the water runoff and that there was "no water reactive material as residue" [WVDEQP 50352].

3.3.7.5 Nalco Chemical (6330 West Van Buren Street)

A hazardous materials incident report was filed for fork lift damage to a 55-gallon drum in a Nalco Chemical "T.T. van" on September 16, 1989 [WVDEQP 49812]. The incident received incident number 89-287. According to the report, the material involved included a "VI – SEP 716 emulsion beraker [sic]" and "Flam liquid NOS 1993, methanol" [WVDEQP 49812]. Control efforts included contacting a chemical waste management company and the City of Phoenix Fire Department Hazardous Materials team on standby at the scene [WVDEQP 49812-49813].

3.3.7.6 South Western Ice (5925 West Van Buren Street)

An ERNS incident notification report was filed on March 25, 1996, for the release of 85 pounds of anhydrous ammonia into the air at the South Western Ice facility. The incident received ERU number 96-020-B. The report lists the failed seal on the refrigeration unit's compressor as the cause of the release. The facility was evacuated in response to the release. Remedial actions included closing the valves and rebuilding the compressor [WVDEQP 50540-50542].

3.3.7.7 Unknown/City of Phoenix (4839 West Brill Street)

An ERNS incident notification report was filed on April 26, 2001, for the dumping of oil over the curb and sidewalk of a 2- by 3-foot decorative walk area by unknown persons. The incident received ERU number 01-039-C. The City of Phoenix contracted Safety Kleen, Inc., to conduct the cleanup and removal of the oil and any contaminated soil [WVDEQP 49804-49806].

3.3.7.8 Unknown (624 North 44th Avenue)

An ERNS incident notification report was filed on May 4, 2000, for the dumping of "clan lab materials" from an unknown source. The report lists "none" as the medium affected and damage is also listed as "none." The report lists the material type as oil and the cause description is a "small boxed up lab." The liquid materials were stored in portable plastic and glass jars and jugs. The incident received ERU number 00-139E. The City of Phoenix contracted Safety Kleen, Inc., to remove the lab materials [WVDEQP 49807-49809].

3.3.7.9 Unknown (304 South 67th Avenue)

An ERNS incident notification report was filed on March 11, 1998, for illegal/clandestine drug manufacturing laboratory materials in a travel trailer. The incident received ERU number 98-118E. The incident report states that the City of Phoenix Police Department investigated the trailer. The City of Phoenix Fire Department responded to a fire in a travel trailer and the remains of a drug lab were found in the debris. All chemicals had been consumed in the fire.⁵⁴ The U.S. Drug Enforcement Agency funded the cost of the cleanup [WVDEQP 49800-49801].

3.3.8 Air Quality Files Results

The ADEQ MegaSearch and AZURITE databases listed air quality files for three businesses located within the industrial survey boundaries: Belden Communications Division, 505 North 51st Avenue; Powerscreen Southwest, Inc. (Powerscreen), 304 South 67th Avenue; and T.S.R. Contracting, Inc., 30 North 63rd Avenue. The results for Belden Communications Division were not reviewed as they were addressed previously in HGL's March 29, 2004, letter report concerning AT&T Technologies, which was located at the same address. See Section 2.3 for a summary of information found on these facilities.

3.3.8.1 Powerscreen Southwest, Inc. (304 South 67th Avenue)

Powerscreen was issued air quality control permit number P1472P0-00 on July 11, 1995, for the operation of a crushing and screening plant [WVDEQP 50453]. However, this was an incorrect classification, and thus Powerscreen was issued an air quality control general permit for the operation of stationary and/or portable crushing/screen plants on September 23, 1999 [WVDEQP 50452, 50454].

Powerscreen was issued a separate air quality control general permit for crushing and screening plants operating in Arizona on August 24, 2000, with coverage granted on November 8, 2001. It received coverage number 1001746 and ADEQ general permit number 102 [WVDEQP 50486-50487]. On November 8, 2001, Powerscreen received an authorization to operate (A.T.O.) under this permit. The following models of screens are listed as equipment under the permit: two Chieftans (A.T.O. numbers 102908 and 102915), two Mark IIs (A.T.O. numbers 102913 and 102914), and a Power Grid (A.T.O. number 102916) [WVDEQP 50481-50485].

On August 16, 1999, Powerscreen filed a standard permit application form to renew permit number P1472P0-00 that had an expiration date of July 10, 2000. ⁵⁵ Rental and sales of screens and "conveyor" is listed under the section of the application for "Equipment Name/Purpose." The following models of screens are listed as equipment on the form: "Chieftain, MKII, M60, M70, and Powergrid" [WVDEQP 50479, 50508].

According to an air emissions inventory questionnaire for the year 2000, which Powerscreen completed on August 28, 2001, Powerscreen emitted 0.2016 tons of VOCs.⁵⁶ The air quality permit number listed is 1000893 [WVDEQP 50461, 50466].

On October 9, 2001, Powerscreen filed an additional standard permit application form to renew permit number P14728 that had an expiration date of July 10, 2000. Rental and sales of screens and "conveyor" is listed under the section of the application for "Equipment Name/Purpose." The following models of screens are listed as equipment on the form: "Chieftian, MKII, M60, M70, and Powergrid" [WVDEQP 50488].⁵⁷

On November 12, 2002, ADEQ issued Powerscreen a notice of violation for failure to submit an annual emissions inventory questionnaire for permit number 1001746.⁵⁸ Powerscreen was required to submit the 2001 emissions inventory in response to the notice of violation [WVDEQP 50475-50476].

According to an emissions inventory report for 2001 dated September 22, 2003, Powerscreen's emissions were below 1 ton, which is below the threshold [WVDEQP 50458]. ⁵⁹ According to an emissions inventory report for 2002 dated November 14, 2003, Powerscreen operated its equipment for 900 hours in 2002, producing less than 1 ton of emissions, which is below the threshold. ⁵⁹ According to the report, Powerscreen had sold its equipment and intended to revise its permit when it had purchased new equipment [WVDEQP 50456-504567].

3.3.8.2 T.S.R. Contracting, Inc. (30 North 63rd Avenue)

On June 22, 1999, ADEQ issued a "notice of opportunity to correct deficiency" to T.S.R. Contracting, Inc., following its failure to submit a 1998 emissions inventory questionnaire by March 31, 1999. T.S.R. Contracting, Inc., was given 30 calendar days from the receipt of the notice to submit the questionnaire [WVDEQP 50551-50553].

On August 19, 1999, ADEQ issued T.S.R. Contracting, Inc., a notice of violation for failure to submit an annual emissions inventory questionnaire for permit number P1465P0-00. The notice indicates that T.S.R. Contracting, Inc., failed to submit the questionnaire within 30 days of receipt of the June 22, 1999, "notice of opportunity to correct deficiency." T.S.R.

Contracting, Inc., was given the opportunity to schedule an appointment to discuss the issue [WVDEQP 50549-50550].⁶⁰

3.4 MARICOPA COUNTY

3.4.1 Maricopa County Air Quality Department File Results

HGL reviewed Maricopa County Air Quality Department files for the following 10 facilities within the industrial survey boundaries: Ameripride Linen & Apparel Service; Crane Trucking; a DEMD, LLC warehouse located at 520 South 67th Avenue; Jacks Tire & Oil; Madera Component Systems, Inc.; Palo Verde Cabinets Company, Inc.; PW Pipe; Sharon Stair Systems, LTD; Varistar Corporation; and Vinyltech Corporation. None of these files contained documents indicating the use of WQARF site COCs or other site contaminants.

3.4.1.1 Ameripride Linen & Apparel Service (6025 West Van Buren Street)

The Maricopa County Air Quality Department issued permit number 990323 to Ameripride Linen & Apparel Service on February 11, 2000. The permit must be renewed by February 28, 2015. According to a public notice issued by the Maricopa County Air Quality Department, the facility is an industrial laundry service. An equipment list provided with the permit application indicates that a natural gas boiler, a natural gas heater, and three natural gas dryers were located at the facility. In addition, the list identifies a Recyclean solvent cleaner that was installed in August 1997, had a 15-gallon capacity, and was manufactured by Safety Kleen [WVMCAQ 950-956].

3.4.1.2 Crane Trucking (440 South 67th Avenue)

The Maricopa County Air Quality Department issued a non-Title V air permit number 8603717 to Crane Trucking on July 15, 1995. The Maricopa County Air Quality Production Database lists the type of business as "gas non-resale." The permit expired on August 31, 1996, and was not renewed [WVMCAQ 905].

3.4.1.3 DEMD, LLC Warehouse (520 South 67th Avenue)

DEMD, LLC, the owner of a warehouse located at 520 South 67th Avenue, submitted a National Emission Standards for Hazardous Air Pollutants notification for renovation and demolition activities to the Maricopa County Air Quality Department on March 22, 2010. Old Herman's is the building name listed on asbestos permit number 807. According to the notification, the warehouse was industrial in nature, and would be demolished between April 5, 2010, and March 19, 2011 [WVMCAQ 906-908].⁶¹

3.4.1.4 Jacks Tire & Oil (5925 West Monroe Street)

The Maricopa County Air Quality Department issued non-Title V permit number 040131 to Jacks Tire & Oil on November 24, 2004. The permit is scheduled to expire on November 30, 2014. The permit lists the sources of air emissions as tire retreading and industrial fuel burning [WVMCAQ 1016].⁶²

3.4.1.5 Madera Component Systems, Inc. (6323 West Van Buren Street)

The Maricopa County Air Quality Department issued permit number 010062 to Madera Component Systems, Inc., a wood truss manufacturing facility, on October 31, 2003. The permit was revised on May 7, 2008.⁶³ Madera Component Systems, Inc., was permitted to emit up to 28 pounds of particulate matter per day [WVMCAQ 921-936].

3.4.1.6 Palo Verde Cabinets Company, Inc. (4625 West McDowell Road)

The Maricopa County Air Quality Department issued permit number 030187 to Palo Verde Cabinets Company, Inc., on January 8, 2004. The permit was renewed on January 31, 2009. According to the permit, equipment used at the facility included saws, sanders, dust collectors, and a spray booth [WVMCAQ 987-988].⁶⁴

3.4.1.7 PW Pipe (425 South 67th Avenue)

The Maricopa County Air Quality Department issued non-Title V permit number 950200 to PW Pipe on June 30, 2001. The permit states that the sources of emissions from the plant were plastics/foam, commercial fuel burning, and printing. The permit was closed on November 19, 2001, after PW Pipe went out of business. PW Pipe was owned by Eagle Pacific Industries, Inc. [WVMCAQ 1029].

3.4.1.8 Sharon Stair Systems LTD (6029 West Washington Street)

The Maricopa County Air Quality Department issued permit number G02067 to Sharon Stair Systems LTD on February 26, 2002. The permit was renewed on June 14, 2010. An equipment list provided as part of the permit lists an "Enclosure - 70X48X8.7" [WVMCAQ 1052]. 65

3.4.1.9 Varistar Corporation (201 South 61st Avenue)

The Maricopa County Air Quality Department issued permit number 000288 to Varistar Corporation on June 12, 2001. The permit is scheduled to expire on June 30, 2016. The

equipment list submitted with the permit lists 1 cold cleaner, 2 miller granulators, 7 printers, 7 extruders, 7 saws, 4 chillers, 7 bellers, 27 coolers, 6 air compressors, 7 pullers, 6 blowers, 1 blender, various emission control devices, and other equipment. 66 Additionally, an aboveground storage tank with a rated capacity of 500 gallons was reportedly used for propane storage [WVMCAQ 1011-1013].

3.4.1.10 Vinyltech Corporation (201 South 61st Avenue)

The Maricopa County Air Quality Department issued permit number 000288 to Vinyltech Corporation, a polyvinyl chloride pipe manufacturer, on June 12, 2001. The permit is scheduled to expire on June 30, 2016 [WVMCAQ 995-1010].

3.5 CITY OF PHOENIX

3.5.1 City of Phoenix Fire Department File Results

HGL initially supplied the City of Phoenix Fire Department with 31 addresses associated with 35 companies that had RCRA identification numbers. The City of Phoenix Fire Department researched its files, which are organized by address, and identified an additional 36 companies associated with the originally supplied 31 addresses. At the request of ADEQ, HGL supplied the City of Phoenix Fire Department with an additional five addresses and one intersection associated with companies that are mentioned in Section 4.1 of this report, but that did not have RCRA identification numbers associated with them, and summarized the results below. None of the files specifically listed use of the WQARF site COCs or other site contaminants identified by ADEQ. The companies discussed in Sections 3.5.1.1 through 3.5.1.30 below had documented uses of fuel, flammable/combustible liquids, or hazardous materials. The companies that did not have documented uses of these materials are listed in Table 3.8.

Results for AT&T Technologies, Belden Communications, Cable Systems International, Inc., Maximet Corporation, Petco, Inc., and Salesco Systems USA were excluded from this report, as they were addressed in previous HGL reports. See Section 2.3 for a summary of information found on these facilities and previously presented to ADEQ in letter reports.

3.5.1.1 7-Eleven Store No. **22631** (5050 West McDowell Road)

On August 10, 1994, the City of Phoenix Fire Department issued permit number 94-7364 to 7-Eleven for the modification of USTs. On November 10, 1994, it was reported that no leaks had been found in the tanks [WVFDPX 1104-1105]. On April 14, 2000, a permit was issued for the removal of four 10,000-gallon USTs [WVFDPX 1078]. An April 25, 2000, tank closure report indicates that each of the tanks had a capacity of 12,000 gallons [WVFDPX 1079].

3.5.1.2 Ameripride Linen & Apparel (6025 West Van Buren Street)

On April 2, 2007, the City of Phoenix Fire Department issued permit number F214 0702645 to Ameripride Linen & Apparel for the installation of a bulk chemical distribution system to include tanks and process piping [WVFDPX 1111]. On March 27, 2008, permit number F213 0802032 was issued to allow Ameripride Linen & Apparel to store, handle, dispense, or use hazardous materials of an unspecified nature [WVFDPX 1115].

3.5.1.3 Arts Complete Auto Service (6425 West Van Buren Street)

City of Phoenix Fire Department permit number 30541, issued on May 24, 1983, allowed for welding and cutting operations at this facility [WVFDPX 931].⁶⁹

3.5.1.4 AutoZone (4335 West McDowell Road)

A notice of violation dated November 29, 2012, cited no violations at 4335 West McDowell Road [WVFDPX 860]. A permit was issued on November 9, 2012, to the Genuine Parts Company – Autozone No. 2768 for the storage, handling, and use of flammable and combustible liquids. The permit number listed on the document is illegible [WVFDPX 861].

3.5.1.5 Charles M. Schayer, Inc. (4703 West Brill Street)

Several violations were cited at Charles M. Schayer, Inc., in an occupancy activity report (OAR) dated May 22, 2002. These included electrical issues, signage issues, exit identification, fire protection system placement, relocation of the liquefied petroleum gas, reduction in the quantity of liquefied petroleum gas stored on site, and required permits. All violations had been corrected as of August 16, 2002 [WVFDPX 864-869].

City of Phoenix Fire Department permit number F224 0202005 was issued on June 20, 2002, to Charles M. Schayer & Co. for the storage, use, handling, and dispensing of liquefied petroleum gases [WVFDPX 870].

69 HGL's prior investigation of business types, conducted on behalf of ADEQ for other industrial surveys in

Arizona under Contract No. 01-0069, indicates that welding operations commonly use the COC TCE in de minimis quantities.

3.5.1.6 Circle K Food Store No. 0608 (6440 West Van Buren Street)

According to an undated City of Phoenix Fire Department inspection record, permit number 10991 was issued on June 4, 1974, to Circle K Food Store to install two 10,000-gallon and one 550-gallon USTs, as well as three subpumps, three leak detectors, and three dispensers. The same document indicates that permit number 15617, to remove a 1,000-gallon UST and install one 6,000-gallon UST, was issued on April 4, 1977 [WVFDPX 1118]. A January 24, 1994, OAR indicates that the Circle K Store applied for a permit to remove one 6,000-gallon UST and two 10,000-gallon USTs [WVFDPX 1122]. Circle K Store No. 0608 removed the 6,000-gallon tank and the two 10,000-gallon tanks on February 1, 1994. Three samples were taken under each 10,000-gallon tank, two under the 6,000-gallon tank, two along the piping, and one under each dispenser [WVFDPX 1119-1120]. 70,71

3.5.1.7 Creative Images, Inc. (6025 West Monroe Road)

A mostly illegible certificate of occupancy was issued on November 7, 1988, for this address [WVFDPX 833]. A June 23, 1989, OAR for a chlorine inspection cites violations for the storage, handling, and use of hazardous materials as well as fire code permit violations. The violations were related to the storage of chlorine at the facility; however, they were resolved with the removal of all chlorine from the facility as of August 29, 1989 [WVFDPX 834-836].

3.5.1.8 Duke Construction LP (520 South 67th Avenue)

On December 19, 2007, permit number F140 0709746 was issued for the installation of a 165-gallon aboveground fuel storage tank located inside the building to feed a fire pump. This tank was inspected via an OAR dated December 20, 2007. The inspection found that all plan notes had been met, and a green tag was issued for the operation of the tank [WVFDPX 823-825].⁷²

3.5.1.9 <u>Dunn Edwards Corp (520 South 67th Avenue)</u>

City of Phoenix Fire Department permit number F142 1006548 was issued on December 22, 2010, for a 300-gallon diesel fuel tank on an emergency generator [WVFDPX 821-822].

3.5.1.10 First Industrial Development Services, LLC (4625 West McDowell Road)

City of Phoenix Fire Department permit number F137 0400987 was issued on March 24, 2004, for the installation of a spray paint booth [WVFDPX 856]. Certificates of occupancy were issued on July 1, 2003, July 3, 2003, September 8, 2003, and January 29, 2009, for commercial remodeling and updating [WVFDPX 854-855].

3.5.1.11 Freeport Logistics, Inc. (431 North 47th Avenue)

An OAR completed November 20, 1985, notes that a permit was issued to install two 10,000-gallon USTs for an undisclosed purpose. A November 22, 1985, OAR notes that the tanks were checked for cathodic protection and that both tanks were coated. The City of Phoenix Fire Department issued permit number F200 1203613 on June 25, 2012, to conduct hot work, including cutting and welding [WVFDPX 1067-1069]. An OAR completed October 9, 1992, granted a permit for the removal of the two 10,000-gallon USTs [WVFDPX 1072]. An October 14, 1992, on-site UST closure report notes that the facility was a warehouse called the "Leaseway Distribution Center," and states that three samples were taken 3 to 4 feet beneath each tank, and two samples were taken along piping [WVFDPX 1073-1074].

3.5.1.12 Huhtamaki Plastics (402 North 44th Avenue)

An OAR completed on January 8, 2003, notes a number of violations to be remedied. These included a request to replace and maintain in place covers or plugs for empty flammable or combustible liquids containers, to provide spill control for flammable/combustible liquids, and to obtain a permit for storing, handling, and using such liquids. Other violations included exit path delineation, proper access to electrical and water sources, and proper signage (exit and no smoking signs). As of April 16, 2003, corrections had been made and permits were delivered [WVFDPX 909-915].

City of Phoenix Fire Department permit number F1730201601 to store, handle, or use flammable or combustible liquids was issued on May 1, 2002, to Huhtamaki Plastics. On the same date, permit number F2130201503 also was issued to Huhtamaki Plastics to store, handle, dispense, or use hazardous materials [WVFDPX 916-917].⁷⁵

3.5.1.13 Ingram Paper Company (430 North 47th Avenue)

The City of Phoenix Fire Department issued permit number 41057 to Ingram Paper Company on December 18, 1985, for the storage and handling of combustible fibers and materials. An April 24, 1994, hazardous materials incident report for this facility notes a release of 10 gallons of diesel fuel from a truck onto the ground [WVFDPX 953-954]. ⁷⁶

3.5.1.14Innovative Environmental Products (4645 West McDowell Road)

An April 25, 2002, OAR identified violations such as the following: a lack of nameplates for two 6,000-gallon storage tanks; tank fill connections being too close to building openings; holes on the top of the tanks; and the need for a permit to store, use, and handle liquefied petroleum gas [WVFDPX 850-852]. On August 7, 2002, the City of Phoenix Fire Department

issued permit number F224 0202507 to Innovative Environmental Products for the use, storage, handling, and dispensing of liquefied petroleum gases [WVFDPX 853].

3.5.1.15 Ken's Custom Detail (304 South 67th Avenue)

An OAR generated January 26, 1984, identified the need for fire code permits for welding and cutting operations, garage services and repairs, and storage and handling of flammable liquids [WVFDPX 814].⁷⁷

On February 8, 1984, the City of Phoenix Fire Department issued permit number 34058 for welding and cutting operations. On the same date, permit number 34056 was issued for the storage, use, and dispensing of flammable/combustible liquids in the process of owning and operating a self-service station [WVFDPX 812-813].

3.5.1.16 Kiser Harriss Chemical Distribution Centers, Inc. (4441 West Polk Street)

A certificate of occupancy for tenant improvements at 4441 West Polk Street was issued to J&J Construction of 2141 East Highland on September 26, 1988 [WVFDPX 832].

An OAR supplement dated December 22, 2009, notes that several incompatible substances had to be separated and that an emergency information cabinet had to be installed at the Kiser Harriss Chemical Distribution Centers, Inc., facility. Noted issues were corrected by March 17, 2011 [WVFDPX 831].

City of Phoenix permit number F213 1702341 was issued to the Kiser Harriss Chemical Distribution Centers, Inc., on April 14, 2011, for the use, storage, and handling of hazardous materials [WVFDPX 830].

3.5.1.17 Lamberton Industries (425 South 67th Avenue)

City of Phoenix Fire Department permit number 55233 was issued to Lamberton Industries on March 27, 1989, for the storage, handling, or use of compressed gases and for welding and cutting [WVFDPX 818].⁷⁹

3.5.1.18 Lorn Technical Coatings, Division of Maximet (116 North 59th Avenue)

City of Phoenix permit number 53093 was issued to Lorn Technical Coatings on September 23, 1988, for the installation of a paint spray booth [WVFDPX 1007]. Permit number 53344 was issued on October 31, 1988, for the installation of a second paint spray booth [WVFDPX 1006].⁷⁹

On March 9, 1989, permit number 55050 was issued for welding and cutting operations; the operation of dust producing equipment; oven and furnace operations; the storage, handling, and use of flammable/combustible liquids; and the storage, handling, and use of hazardous chemicals [WVFDPX 1005].⁸⁰

Permit number 69966 was issued on January 5, 1993, for the installation of a paint and spray booth [WVFDPX 1004].

Plans related to permit number 95-644 were logged on February 15, 1995, for the installation of a liquid propane gas system [WVFDPX 1002-1003].

3.5.1.19 Michelin Tire Co. (5925 West Monroe Street)

A fire risk assessment form completed for the Michelin Tire Co. identified a high level of fire risk. The facility received this designation because it did not have fire hydrants within 350 feet of combustibles, fire department access roads that were a minimum of 20 feet wide, 40 feet of separation from fire department access roads to outside combustible storage, or vehicle access gates compliant with Phoenix Fire Code standards. Additionally, the property had outside combustible storage in excess of 30,000 cubic feet, and did not have 50-foot separations between combustible storage piles, lot lines, and other buildings [WVFDPX 840].

3.5.1.20 Mirachem Corporation (4645 West McDowell Road)

A permit was issued on June 8, 2011, to Mirachem Corporation for the use, storage, and handling of hazardous materials. The permit number on the document is illegible [WVFDPX 849].⁸¹

3.5.1.21 Palo Verde Cabinet Company, Inc. (4625 West McDowell Road)

Three OARs were located for Palo Verde Cabinet Company, Inc. The first, dated February 5, 2004, indicates that the company was to cease operation of a spray booth until permits had been obtained, signs had been posted, and the booth had been re-inspected. The second, dated May 6, 2004, identifies improvements, including the installation of a paint booth, and requires an air balance report and final monitoring of the spray booth for final approval. The third OAR, dated June 16, 2004, indicates that operation of the spray booth was approved [WVFDPX 857-859].

3.5.1.22 Palo Verde Enterprises (6215 West Van Buren Street)

A certificate of occupancy was issued on March 3, 1981, to "P.V. Enterprises" for a mercantile warehouse and sales room at 6215 West Van Buren Street [WVFDPX 939].

City of Phoenix Fire Department permit number 37766 was issued on December 12, 1984, for the storage, use, and dispensing of flammable/combustible liquids as the owner and operator of a service station. On the same date, permit number 37768 was issued allowing for welding and cutting operations at this facility [WVFDPX 937-938]. 82

3.5.1.23 Prudence Trucking (430 North 47th Avenue)

An April 28, 1994, hazardous materials investigation report describes a diesel fuel spill that occurred at this location on April 21, 1994. The fuel was leaking from the left saddle tank of a semi-truck and was cleaned up by Prudence Trucking, the owner of the vehicle. The cleanup was inspected and found to be complete on April 22, 1994 [WVFDPX 948].

An OAR dated April 21, 1994, cites Prudence Trucking of 3404 West Papago for a flammable liquid violation and notes that spilled diesel fuel, contaminated soil, and absorbent pads were to be disposed of according to local, state, and federal regulations [WVFDPX 949].

3.5.1.24 Rawson Drug (4645 West Polk Street)

City of Phoenix Fire Department permit number 58284 was issued to Rawson Drug on October 30, 1989, for the storage, handling, and use of Class I, II, or IIIA flammable/combustible liquids [WVFDPX 828]. 83

3.5.1.25 Rugby IPD Corp (4703 West Brill Street)

According to an October 20, 2000, service request form, a general inspection was requested by Rugby IPD Corp to determine amounts of flammable liquids (liquid adhesive) that could be stored at this facility.⁸⁴ During this inspection, the City of Phoenix Fire Department helped Rugby IPD Corp to classify flammable and combustible products so that it could decide how much and what types of products to store [WVFDPX 862].

3.5.1.26 Ruth's Snow Cones (6425 West Van Buren Street)

On March 8, 1963, City of Phoenix Fire Department permit number 849 was issued to Ruth's Snow Cones for the installation of a 1,000-gallon UST. On February 26, 1977, permit number 15132 was issued for the removal of a 1,000-gallon UST and the installation of another 1,000gallon UST [WVFDPX 932, 936].

On February 27, 1996, permit number 74067 was issued for the removal of a 1,000-gallon UST. A March 1, 1996, on-site UST closure report notes that no holes were observed in the tank or piping [WVFDPX 933].

3.5.1.27 Southwest Powder Coating (116 North 59th Avenue)

An October 24, 2001, OAR notes several violations related to the setup, condition, and operation of the powder coating booths at Southwest Powder Coating [WVFDPX 996-999].

City of Phoenix Fire Department permit number F224 0104023 was issued on October 30, 2001, for the storage, handling, use, and dispensing of liquid propane gas. On the same date, permit number F196 0104022 was issued for the application of flammable finishes via a four-booth powder coat spray operation [WVFDPX 1000-1001].

3.5.1.28 Super Valu Logistics (6104 West Washington Street)

A June 27, 2008, letter from the Phoenix Fire Department Special Hazards Unit to the facility maintenance manager of SuperValu Logistics lists 28 fire code violations related to the fire protections systems, signage requirements, and location of materials. All violations were corrected by June 23, 2010 [WVFDPX 901-905].

3.5.1.29 SuperValu Logistics/Fry's Distribution Center/Target (6111 West Washington Street)

City of Phoenix Fire Department permit number F173 0805093 was issued to Fry's Distribution Center on July 18, 2008, for fleet fueling purposes using flammable and combustible liquids [WVFDPX 883].

Permit number F143 0806927 was issued to Fry's Distribution Center on September 24, 2008, for the installation of one 660-gallon generator sub-base tank. An OAR generated October 8, 2008, lists inspection details of a 660-gallon aboveground storage tank; however, the owner is listed as SuperValu Logistics [WVFDPX 881-882].

A January 29, 2009, certificate of occupancy was issued to the Ryan Companies of 1 North Central Avenue for the commercial remodeling of 6111 West Washington Street [WVFDPX 880].

A September 22, 2010, permit was issued to Fry's Distribution Center for the installation of new valves and piping to an existing ammonia system. A September 27, 2010, OAR states that a green tag was issued for the upgraded valves and piping [WVFDPX 895-896]. 85

On December 28, 2010, a permit with an illegible permit number was issued to Fry's Distribution Center for the use, storage, or handling of compressed gases. On the same date, another permit with an illegible permit number was issued to Fry's Distribution Center for the

use, storage, or handling of flammable and combustible liquids. Also on December 28, 2010, a third permit, also illegible, was issued to Fry's Distribution Center for the use, storage, and handling of hazardous materials [WVFDPX 877-879].

On January 27, 2012, permit number F235 1200528 was issued to Fry's Distribution Center for the installation of a banana ripening room with ethylene gas and ammonia system upgrade. Inspections of the installation, which is listed as located at the Target facility, were conducted on February 13, March 9, March 27, May 2 and 3, and June 21, 2012, and reports note that requirements for a green tag, among other things, include providing the guard shack with an updated copy of an emergency response plan and relocating a wet stand pipe sign above stand pipe outlets. A July 5, 2012, OAR of Target documents a complete inspection and approves the installation [WVFDPX 884-892].

An undated permit with an illegible permit number was issued to Fry's Distribution Center for the modification of an existing "ammonia system-phase 2." An OAR generated September 6, 2012, lists the system as inspected and approved [WVFDPX 893-894].

3.5.1.30 Total Warehouse, Inc. (402 North 44th Avenue)

An OAR generated on June 17, 1993, for Total Warehouse, Inc., and identifies several violations at the facility. The violations cited were related to locks and latches, exit signs, sprinkler systems, and portable extinguishers. All issues were remedied by February 4, 1994 [WVFDPX 919-921].

City of Phoenix Fire Department permits numbers 66229 and 66229A were issued on December 16, 1991, to install one 500-gallon liquefied petroleum gas tank [WVFDPX 921-922].

3.5.1.31 Total Warehouse, Inc. (4411 West Roosevelt Street)

Two certificates of occupancy, dated December 18, 1998, were found for 4411 West Roosevelt Street. They were issued to Joe E. Woods, Inc., of Mesa, Arizona, for a one-story building and tenant improvements [WVFDPX 942].

City of Phoenix Fire Department permit number 99-735 was issued on February 18, 1999, for the installation of a 125-gallon liquid propane tank [WVFDPX 943-945].

An OAR dated October 28, 2004, cites violations for improper fire signage, and damaged and inoperable emergency lights [WVFDPX 945].

On November 23, 2004, permit number F224 0404308 was issued for the storage, use, handling, and dispensing of liquid propane gas. On the same date, permit number F173 0404343 was issued for the storage, use, and handling of flammable and combustible liquids [WVFDPX 946-947].

3.5.1.32 Verizon Wireless (505 North 51st Avenue)

An OAR conducted on December 21, 2004, required a permit for the storage of diesel fuel, a vent for the diesel tank, and an emergency vent for the same tank. All cited violations were corrected by June 9, 2005 [WVFDPX 960].

City of Phoenix Fire Department permit number F173 0502009 was issued to Verizon Wireless on May 19, 2005, for the storage, handling, and use of flammable and combustible liquids [WVFDPX 961].⁸⁷

3.5.1.33 Vinyltech Corporation (201 South 61st Avenue)

Two certificates of occupancy were found for 201 South 61st Avenue. The first, dated February 21, 1984, was issued for an addition to the manufacturing facility. The second, undated, was issued for the shell of the manufacturing building [WVFDPX 801].

City of Phoenix Fire Department permit number 51726 was issued to Vinyltech Corporation on May 20, 1988, for the storage, handling, or use of flammable/combustible liquids. The permit also allowed for welding or cutting at specific locations [WVFDPX 795]. 88,89

Permit number R432 was issued on August 30, 1993, for the storage and handling of a 500-gallon liquid petroleum gas tank. Permit number R432 93-1252 was issued on August 31, 1993, for the installation of one 500-gallon liquid petroleum gas tank [WVFDPX 796-798].

An OAR dated May 18, 1988, lists violations for flammable/combustible liquids, fire code permits, and fire doors. These violations included the requirement of an emergency fuel shut-off switch for the propane dispenser. All violations were corrected by June 6, 1988 [WVFDPX 799-800].

3.5.1.34 Western Electric Company (505 North 51st Avenue)

From 1969 to 1977, the City of Phoenix Fire Department issued the following permits to the Western Electric facility at 505 North 51st Avenue:

• On October 13, 1969, permit number 4729 was issued for the storage and handling of hazardous materials [WVFDPX 995]. 90

- On December 4, 1970, permit number 5830 was issued for the installation and use of a spray booth [WVFDPX 871].
- On October 13, 1972, permit number 8616 was issued for the installation of a 1,000-gallon liquid petroleum gas tank [WVFDPX 995].
- On September 8, 1974, permit number 10732 was issued for the installation of a 10,000-gallon gasoline UST with a leak detector, a "sub pump," and piping [WVFDPX 872].
- On May 12, 1977, permit number 15842 was issued for the installation of two 1,000-gallon liquid petroleum gas tanks [WVFDPX 994].
- On August 31, 1977, permit number 16376 was issued for the transfer of gasoline from a 6,000-gallon UST to a 10,000-gallon UST [WVFDPX 994].

A certificate of occupancy for an 80- by 320-foot addition to the main building was filed in 1978. Another certificate was issued on September 17, 1981, for an oil storage building [WVFDPX 993].

Permit number 19457 was issued to the Western Electric Company on April 25, 1979, to install one 10,000-gallon gasoline UST with a 1/3 horsepower turbine, a leak detector, a "subpump," and piping [WVFDPX 873].

A property inspection report completed on May 8, 1979, approved the "cover up" of a 10,000-gallon tank installed via permit number 19457 [WVFDPX 969].

An August 18, 1980, OAR approved plans for the installation and operation of a gas chlorinating system. An OAR generated on September 20, 1982, approved the piping for one diesel dispenser tank [WVFDPX 967-968].

According to a January 20, 1983, OAR, Western Electric Company was to remove all combustibles from stairwells and display a flammable sign. These violations were remedied as of February 22, 1983 [WVFDPX 987].

On December 22, 1983, a UST was removed under permit number 33483 [WVFDPX 966].91

3.5.2 City of Phoenix Water Services Department – Pollution Control Division Files Results

HGL reviewed City of Phoenix Water Services Department files for three facilities: Ameripride Services, Inc., G&K Services, Inc., and Phoenix Metalcraft, Inc. The Phoenix Metalcraft, Inc., facility is located outside of the industrial survey boundaries at 3845 North 29th Avenue. Files for this facility did not indicate the use or discharge of WQARF site COCs or other site contaminants and were therefore excluded from this industrial survey.

3.5.2.1 Ameripride Services, Inc. (6025 West Van Buren Street)

According to an April 4, 2008, industrial wastewater permit application, Ameripride Services, Inc., produced wastewater while washing textiles. Ameripride Services, Inc., discarded 79,330 gallons of wastewater per day into the City of Phoenix sanitary sewer system, but did not report the discharge of any WQARF site COCs or other site contaminants. This permit was issued July 1, 2008, and expired June 30, 2013 [WVCPWS 1539-1575]. The City of Phoenix Water Services Department issued a new permit to Ameripride Services, Inc., on July 1, 2013, for the discharge of an average of 119,000 gallons per day. It has an expiration date of June 30, 2018 [WVCPWS 1620-1623].

3.5.2.2 G&K Services, Inc. (4804 West Roosevelt Street)

According to an August 20, 2012, industrial wastewater permit application, G&K Services, Inc., produced wastewater during three processes: industrial laundering, boiler blowdown, and water softener regeneration. G&K Services, Inc., discharged 82,038 gallons of wastewater a day. G&K Services, Inc., reported discharging 0.005 pounds of PCE per gallon of wastewater per day. Additionally, 0.01 pounds of ethylbenzene and 0.06 pounds of toluene per gallon of wastewater per day were discharged. No other WQARF site COCs or other site contaminants were reported in wastewater discharge from the facility. According to this permit application, the origin of these chemicals was the soiled print and shop towels from industrial customers [WVCPWS 1601-1619]. The Class A permit to discharge industrial wastewater into the City of Phoenix sanitary sewer system was issued on September 27, 2012, and expires on September 30, 2017 [WVCPWS 1594].

3.6 HYDROGEOLOGIC, INC., WATER QUALITY ASSURANCE REVOLVING FUND SITE FILES RESULTS

HGL searched its WQARF site files for information pertaining to facilities within the industrial survey boundaries. The WQARF site files included documents on the following seven facilities: Ameripride Services, Inc., Banner Construction Company, Inc., Crane Trucking/Crane & Hayes Trucking, Imagineering, Inc./Creative Images, Inc., G&K Services, Inc., G.I. Trucking, and Ray Hoopes Concrete Company.

3.6.1 Ameripride Services, Inc. (6025 West Van Buren Street)

Two documents were identified in the HGL WQARF files with information relating to Ameripride Services, Inc., including a December 13, 1999, interoffice memorandum sent from ADEQ to the Arizona Attorney General's Office, and another document, dated August 24, 1999, prepared by ADEQ discussing significant industrial users. Both documents are attorney-client privileged and cannot be summarized in this industrial survey [WVDEQI 7339-7356, 8150].

3.6.2 Banner Construction Company, Inc. (6805 West Van Buren Street)

According to an undated hazardous materials questionnaire, Banner Construction Company, Inc., operated at 6805 West Van Buren Street since 1959 as a construction company specializing in underground pipeline construction. The company had 30 employees on the date the questionnaire was completed, and its facility included a corporate office, yard, and maintenance department. The previous owner of the property was a farmer named Walter L. Poppe. The company listed Boyd W. Thompson as its company representative. The company reported that it did not generate, transport, treat, store, or dispose of hazardous materials. It also stated that the company had never had a chemical, solvent, or hazardous substance spill, leak, or release. According to the questionnaire, the facility had two USTs, one containing 500 gallons of gasoline and another containing 1,000 gallons of diesel [WVDEQI 545].

3.6.3 Crane Trucking/Crane & Hayes Trucking (440 South 67th Avenue)

A June 28, 1989, repair facility inspection report for solvent use notes that Crane & Hayes Trucking, then operating at 440 South 67th Avenue and owned by Ted Crane, was in the business of trucking and harvesting since about 1967. The report states that gasoline or diesel was used to clean parts, and that hazardous waste oil drums/tanks were occasionally pumped by an unknown company. Crane & Hayes Trucking had never had any dry wells or water wells on its property, but it did have a septic tank for a "commode." The report notes that the operation was small, appeared clean, and had no signs of solvent use [WVDEQI 1431].

A June 19, 1990, environmental property evaluation of the Estrella Business Park, located near the northwest corner of 63rd Avenue and Buckeye Road, conducted by Western Technologies, Inc., for TCW Realty Advisors, notes that Crane & Hayes Trucking had four USTs [WVDEQP 10157]. 94

3.6.4 Imagineering, Inc./Creative Images, Inc. (6025 West Van Buren Street)

According to a January 16, 1987, Material Safety Data Sheet, cream makeup manufactured by Creative Images, Inc., contained no hazardous components as defined by the Occupational Safety and Health Administration's Hazard Communication Standard, 29 Code of Federal Regulation 1910.1200 [WVDEQI 8903].

According to an undated City of Phoenix pollution prevention survey and inspection report, Imagineering, Inc., manufactured molds, plastic masks, and cosmetics. The survey lists mercury, lead, and chromium as pollutants of concern for the facility. Imagineering, Inc., stated that it did not have a pollution prevention plan, and that dry wells and storm sewers were located on the property. The survey notes that a red stain was found in the rear of the building [WVDEQI 8905-8908].

3.6.5 G&K Services, Inc. (4804 West Roosevelt Street)

As of January 4, 1999, the City of Phoenix named G&K Services, Inc., located at 4804 West Roosevelt Street, a significant industrial user holding a wastewater discharge permit [WVDEQI 14418]. A September 10, 1999, document relating to G&K Services, Inc., was excluded from this report due to its privileged status [WVDEQI 20063].

3.6.6 G.I. Trucking (5939 West Washington Street)

A June 30, 1989, repair facility inspection for solvent use report notes that G.I. Trucking was a trucking business that had been at its 5939 West Washington Street location since about 1981 and that the company was the first industrial user of the land. The inspection states that G.I. Trucking had used one unit manufactured by Safety Kleen, Inc., to clean parts since its start of business, and had two USTs holding 10,000 gallons of diesel fuel. Additionally, G.I. Trucking had one dry well, but no septic system or water wells at the facility. The survey states that waste oil was returned to California or that someone from Bud's Oil Service would "come in to pump it off." A handwritten note states that minimal maintenance was performed at the facility and that no signs of staining or abuse of the lot were observed [WVDEQI 1404-1405].

3.6.7 Ray Hoopes Concrete Company (224 North 59th Avenue)


A May 29, 1998, Environmental FirstSearch conducted by Dominion Environmental Consultants for Arizona Partsmaster on 15 North 57th Drive identified facilities that store and handle hazardous substances or petroleum products in the vicinity of the Arizona Partsmaster property. According to the report, two 2,000 gallon USTs used to store gasoline and diesel at the Ray Hoopes Concrete Company facility on 224 North 59th Avenue. The report indicates that on May 8, 1991, a LUST was reported at the Ray Hoopes Concrete Company facility, but the capacity and content of the tank were not reported [WVDEQP 519, 523, 527, 559, 567]. 97

4.0 CONCLUSIONS, DATA GAPS, AND RECOMMENDATIONS


This section provides conclusions regarding the industrial survey, identifies data gaps, and presents recommendations for additional research based on information identified during the development of this report.


4.1 CONCLUSIONS

The results of the industrial survey research indicate evidence of the release or presence of WQARF site COCs or other site contaminants at the following company facilities located within or in close proximity to the industrial survey boundaries: 7-Eleven Store No. 22631, 5050 West McDowell Road; Ameripride Linen & Apparel Service, 6025 West Van Buren Street; Arizona Meadows, 67th Avenue and Durango Street; Circle K Stores, Inc., No. 0608, 6440 West Van Buren Street; G&K Services, Inc., 4804 West Roosevelt Street; Imagineering, Inc./Creative Images, Inc., 6025 West Van Buren Street; Southwest Freeport/The RREEF Funds, 431 North 47th Avenue; and Varistar Corporation, 201 South 61st Avenue. Figure 4.1 depicts the location of these facilities. The facilities listed in Table 2.2 are also located within the industrial survey boundaries and have evidence of the release or presence of the WQARF site COCs 1,1-DCE, 1,1-DCA, chromium, *cis*-1,2-DCE, PCE, and TCE, and 1,1,1-TCA. The facilities have been investigated previously and a brief summary of findings is presented in Section 2.3.

7-Eleven Store No. 22631, located at 5050 West McDowell Road, is located across the street and to the north of Industrial Survey Boundary No. 4b, but was included in this industrial survey because the WQARF site COCs and other site contaminants have been detected in soil and groundwater samples collected from the facility. A release of unleaded gasoline occurred at the facility, and BTEX has been detected above GPLs and SRLs in soil samples collected there [WVDEQP 43180-43182, 43276; see also Table 3.4]. Additionally, benzene, toluene, ethylbenzene, and TCE have been detected above AWQS limits in groundwater samples collected from the facility [WVDEQP 43154, 43279-43281, 43285-43286; see also Table 3.5].

Ameripride Linen & Apparel Service, located at 6025 West Van Buren Street, is an industrial laundry service. Although the company did not report the discharge of any WQARF site COCs into the water supply in its 2008 wastewater permit application, an equipment list provided to the Maricopa County Air Quality Department in 2000 indicates that the facility used a Recyclean solvent cleaner, with a 15-gallon capacity, which was installed in August 1997 [WVMCAQ 950-956].





Arizona Meadows, located at 67th Avenue and Durango Street, is approximately one city block south of Industrial Survey Boundary No. 4a, but was included in this industrial survey because benzene, toluene, and total xylenes were detected above AWQS limits in groundwater samples collected from the facility [WVDEQP 50418-50419]. In 2001, an area of contaminated soil approximately 200 by 110 feet in size was excavated. The contaminants in the soil were TPH and BTEX. Benzene was detected in soil samples above GPLs and SRLs. Contaminated soil was removed, and additional sampling was performed on the walls and bottom of the excavation pit to confirm that levels of the contaminants were below their respective residential SRLs and GPLs. On March 10, 2003, ADEQ notified the property owner that no further action was required for soil [WVDEQP 50418].

The Circle K Store No. 0608, located at 6440 West Van Buren Street, had a release from a premium unleaded product line in 1992 [WVDEQP 43362]. BTEX was detected in soil at the facility, but only xylenes were detected above the GPL [WVDEQP 43370-43371]. Additionally, PCE, TCE, benzene, toluene, and ethylbenzene were detected in groundwater samples above AWQS limits [see Table 3.6].

G&K Services, Inc., located at 4804 West Roosevelt Street, has discharged PCE, ethylbenzene, and toluene into its wastewater as a result of industrial laundering, boiler blowdown, and water softener regeneration [WVCPWS 1601-1619]. On January 4, 1999, the City of Phoenix named G&K Services, Inc., located at 4804 West Roosevelt Street, a significant industrial user holding a wastewater discharge permit [WVDEQI 14418]. Results from an April 14, 2009, soil sampling event detected chromium at concentrations of up to 31 mg/kg in DW-1-35, below the GPL of 590 mg/kg. The COC *cis*-1,2-DCE, and BTEX, were not detected. The samples were not tested for the other site COCs [WVDEQP 55869-55883].

Imagineering, Inc./Creative Images, Inc., located at 6025 West Monroe Street and 6025 West Van Buren Street, manufactured cosmetics, plastic masks, and molds. According to an undated City of Phoenix pollution prevention survey and inspection report, chromium was a pollutant of concern at the Monroe Street facility. The facility did not have a pollution prevention plan and a red stain was found in the rear of the building [WVDEQI 8905-8908].

Southwest Freeport/The RREEF Funds, located at 431 North 47th Avenue, had a release of diesel fuel from a fuel dispenser [WVDEQP 42965]. 98 On June 25, 2012, the City of Phoenix Fire Department issued permit number F200 1203613 to Freeport Logistics to conduct hot work, including cutting and welding [WVFDPX 1107-1109]. 99

Varistar Corporation, located at 201 South 61st Avenue, is currently operating under permit number 000288, issued by the Maricopa County Air Quality Department. According to an equipment list submitted with the permit, the facility uses 1 cold cleaner, 2 miller granulators, 7 printers, 7 extruders, 7 saws, 4 chillers, 7 bellers, 27 coolers, 6 air compressors, 7 pullers, 6 blowers, 1 blender, various emission control devices, and other equipment. Additionally, an

aboveground storage tank with a rated capacity of 500 gallons was reportedly used for propane storage [WVMCAQ 1011-1013]. According to EPA, cold cleaners use a wide variety of solvents, including 1,1,1-TCA [WVEPAW 29]. Hexavalent chromium is used for industrial processes that require anticorrosive agents [WVINET 1909]. Several commercial websites, including Johnson Controls, refer to use of chromate inhibitors, which contain chromium, to prevent corrosion in different types of chillers [WVINET 2214-2215].

4.2 DATA GAPS

At this time, HGL has not identified any data gaps.

4.3 **RECOMMENDATIONS**

Listed below are recommendations for additional research that could provide pertinent information about facilities located within and near the industrial survey boundaries:

• Conduct corporate research on facilities listed in Table 4.1 below. The facilities were selected from Appendix A if 1) the business types are associated with the use and generation of WQARF site COCs or other site contaminants; 2) the facilities operated prior to 1984 when RCRA amendments strengthened waste management provisions; and 3) no regulatory records were found while preparing this industrial survey. Figure 4.2 depicts the location of the facilities listed in Table 4.1 below.





A1.0 INDUSTRIAL SURVEY RESULTS

A1.1 PHOENIX CITY DIRECTORY RESULTS

This appendix contains a list of businesses identified through the review of Phoenix city directories for the West Van Buren Water Quality Assurance Revolving Fund (WQARF) Registry Site (site). HydroGeoLogic, Inc. (HGL) used past research on general business categories typically associated with the use or generation of specific WQARF site contaminants of concern (COCs) and other site contaminants to eliminate companies that were unlikely to have used the WQARF site COCs or other site contaminants. Only businesses that could potentially have used or generated the WQARF site COCs or other site contaminants are listed in Tables A.1 through A.40 below.

HGL reviewed Cole's and Polk's city directories at the Arizona State Capitol Archives Library. City directory reviews were conducted on the 56 address ranges found in Table 2.1 of the industrial survey report. Industrial survey boundary streets were only reviewed for addresses inclusive of the boundaries. Therefore, only odd numbered addresses were reviewed for 51st Avenue, 69th Avenue, McDowell Road, and Roosevelt Street, and only even numbered addresses were reviewed for 43rd and 59th Avenues. Parts of Van Buren Street are included in both Industrial Survey Boundaries Nos. 1 and 2; both even and odd numbered addresses are included in Industrial Survey Boundary No. 1, but only even addresses are included in Industrial Survey Boundary No. 2.

HGL reviewed city directories for the period of 1960 to 2013. Information was obtained from the street address section of the directories. The street address section includes listings that allow for a review of information by individual address. For specific address ranges, HGL collected pages from the directories beginning with the first directory in which commercial or industrial entities appeared for those ranges. The city directories indicate that the first commercial/industrial use of the area began in 1963. The following Phoenix city directories were missing or were not available during the research period: 1962, 1970, 1972, 1974, and 1985.

Tables A.1 through A.40 include the address, business name, years of operation, and business type, if known. Business types were identified by business name. If a business type could not be determined, the business type is listed as "undetermined."


