## AKC Delegate's Report

### AKC Delegate's Report

December 10, 1996 Delegates Meeting

At the Delegates Forum, the Future Nature Committee report was reviewed, suggesting all event-giving clubs become AKC members and that a new regional tier of membership be created. The report generated much discussion of their vision of the future. The question and answer session was taken up totally with questions about the new Advanced Life Support unit requirement for show giving clubs. A non-binding resolution was passed by the delegates requesting that the AKC board review the requirement and refer it to the All Breed Clubs Committee for study.

The proposed amendment to the Rules allowing organizations to be licensed as superintendents, as well as individuals, was adopted. The proposed amendment to the Pointing Breed Field Trial Rules to add an AKC Gun Dog Championship Stakes was adopted. The proposed amendment to the Constitution to clarify the ownership of breed standards (acknowledging the ownership by the parent

clubs with full usage granted to AKC) was adopted.

The Chairman of the Board reported that a 401K plan has been adopted for employees, that provisions are being made to tape breed seminars for wider distribution, that an outside firm has been secured to do performance audits, and that an independent company has been hired to evaluate the AKC relocation proposals. Alexander Draper, on behalf of the Canine Health Foundation, announced that \$315,000 has been distributed this year and commended several individuals who have been instrumental. An announcement was made that Pennsylvania House Bill 397 passed the legislature allowing Pennsylvania municipalities to remove themselves from PA dog legislation laws and pass their own breed specific ordinances. Request was made that as many as possible call the Governor at 717-787-2500 to urge his veto. We viewed a video on AKC's "Dog Day Afternoon." Wayne Cavanaugh discussed recent positive media coverage and the successful Dalmatian Club/AKC work to get media coverage cautioning the public about

purchasing Dalmatians just because of the popularity of the new 101 Dalmatians movie.

The nominating committee report was presented. I will have a list of their nominations and the additional self-nominations for the January meeting in case the Board would like to direct me on voting.

Read for vote at the March meeting (in addition to the AKC board elections) was a proposed amendment to Article XI, Section 1 of AKC's Constitution and Bylaws to make the requirement that the President be a delegate an option. The proposal was made by Elaine Young of the Seattle Kennel Club.

At Fred's request, I had contacted Dr. Edwards' office regarding a new AKC program providing free DNA identification testing through parent clubs. I asked Dr. Edwards about this again, and he advised that the Board has directed him to implement DNA testing only in conjunction with AKC inspections for now. He assured me that we would hear from them when the rest of the program begins.

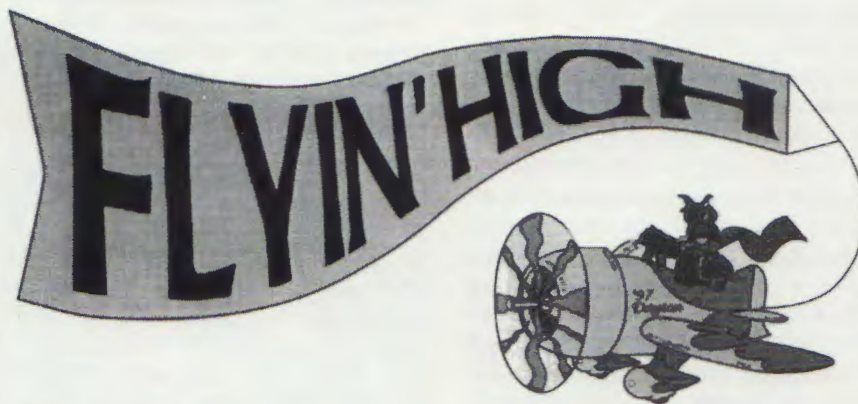

**Corrections and clarification of the Minutes-10-3-1996.** Mary-Ann Cole made a motion that the R-Starr Memorial plaque be paid for by the STCA for 1996 only, in lieu of the STCA sending flowers, 2nd by Fred Brooks, motion passed unanimously. Minutes-10-5-1996. Tax Year-We have not received approval by the IRS to change our current year to a fiscal year. J. Richard Seelbach made the motion that the Board must review and authorize all programs that are to be held in conjunction with dinner meetings. 2nd Jeanie Jennings, motion passed unanimously.

**Report of the Corresponding Secretary-Polly O'Neal** has submitted a written report disclosing all incoming and outgoing correspondence. Approval dates from AKC for 8 regional specialties to be held in 1997 and 1998. She has had many requests for grooming manuals, information on Rescue, and breeder referral. # Artificial Insemination Using Shipped Extended Chilled Semen

Artificial insemination with shipped extended semen is a useful alternative to the shipping of animals. The process is gaining in popularity as it is being refined to give better results. It eliminates animal stress associated with cross country travel, thereby increasing fertility and conception rates. The incidence of missed breedings due to logistical problems associated with animal transport can also be reduced. These logistical problems include: inclement weather, airline delays, holidays, missed flights, and animal temperament. The risk of the bitch contracting or spreading disease is also diminished. However, the challenges associated with monitoring the heat cycle and breeding decisions are transferred to the owner of the female. Due to the limited viability of chilled semen and the timing necessary to procure it, it is necessary to predict the day of ovulation as close as is humanly possible. Success is dependent upon proper semen handling and insemination timing.

We undertook the task of inseminating Belfyre Minute Maid (Midge), a three-year-old Scottie female in Abilene, Texas, with semen from Ch. Anstamm Beat the Rap, a four-year-old male Scottie in Kalamazoo, Michigan. Midge belongs to veteran Scottie breeder Polly O'Neal. Vulvar swelling, vaginal cytology, anterior vaginal vault exams, and serum progesterone values were used to monitor Midge's heat cycle. The entire breeding process can be broken down into several integral parts: 1. Semen extender preparation 2. Semen collection and extension 3. Shipping 4. Insemination.

## EXTENDER

Commercial semen extenders are available as well as home recipes for the do-it-yourselfer. Most of these extenders are advertised as maintaining live semen for up to 48 hours. We decided to use an extender supplied by Dr. Kay Henderson (PhD, Reproductive Physiologist) of Reprospecs in Alpine, California. It is not uncommon for canine semen to remain viable for up to ten days in this extender. The key to this longevity is that the extender preparation is delayed until it is needed. Also, a fairly large volume is used.

Keeping Dr. Henderson apprised of the heat cycle stages for coordinating mixing and shipping of the extender is very important. In our case, the extender was prepared on 8/29/96 and shipped Federal Express Overnight to Michigan. It is shipped in a styrofoam cooler with three freezer packs. Included are three vials of extender and a water blank vial. Once it arrives, the cold packs should be placed in the freezer. The water blank vial should be filled with tap water

and placed with the extender vials in the refrigerator. The refrigerator should be at approximately 40 degrees F.

## COLLECTION

Prior to collection, a coffee cup or other container is filled with 84 to 99 degree F tap water. This can be accomplished by holding a thermometer in running hot water and adjust the cold water mix until the desired temperature is reached. Then fill the container. Remove all three vials of extender and the water blank vial from the refrigerator. Place all vials in the warm water bath. Place a thermometer in the water blank vial. When it reaches 84 to 99 degrees F, the extender should be at the same temperature.

Collect the male in the usual fashion, taking care to only catch the presperm and sperm rich fractions. Evaluate the ejaculate for volume, concentration, and motility. The semen is then divided into three equal fractions and added to the prewarmed extender using a pipette. Number the vials one, two, and three. If the ejaculate is of poor quality, a judgement decision should be made as to whether to add the entire ejaculate to one or two vials.

In our case, the ejaculate was three ml of high concentration, rapid, forwardly motile sperm. One ml of ejaculate was added to seven ml of extender in each of three vials. The extender and semen is gently mixed. Leave all vials in the water bath until they have slowly cooled to room temperature. This usually requires one to two hours. Now place one half ml of extended semen from each vial into three corresponding vials. These will be placed in the refrigerator and held as control vials by the owner of the male dog. The full vials and water blank can now be placed in the shipping box or placed in the refrigerator until ready to send.

## SHIPPING

The most rapid method of shipping should be used, especially during those times of the year when outside temperatures are extremely hot or cold. Transport via airline is probably the most rapid and reliable. If not available, the shipping box should be protective for up to 24 hours. Extensive research of available carriers along with their pickup and delivery times prior to needing them is very helpful.

The room temperature (or refrigerator temperature) semen and water blank vials are placed in the shipping box. The frozen freezer packs are placed around the vials, one below and two above. The semen we used was flown via airplane from Michigan to Abilene, Texas. The box was in transport for approximately eight hours. When the semen arrives, remove it from

the shipping box, then place it and the water blank vial in the refrigerator.

## INSEMINATION

Remove the number one vial and the water blank vial from the refrigerator. Place both in a warm water bath that is 84 to 99 degrees F. Monitor the temperature of the water blank vial. When it reaches 83 degrees F, you are ready to proceed. Place one drop of warmed extended semen on a slide and evaluate for percent motility. As a control measure, the owner of the male dog should perform the same sequence of events on their semen vial number one. This is done at the same time by both parties. The use of control vials will help to determine if the donor male's semen is unsuitable for extension or if there was some sort of insult to the sample during shipment. Each time the female is inseminated, the corresponding control vial should be checked.

The entire content of vial one is inseminated into the cranial vaginal vault. The bitch is held upside down for 15 minutes. Ten seconds of manual clitoral stimulation is applied. She is then crated for at least 30 minutes.

## TIMING OF INSEMINATION

The proper time to inseminate has long been debated. The key parameter to utilize for timing is also controversial. We chose to accumulate as much information as possible and then make a decision. Basically, we were looking to breed when the vulva was at its maximum size, cytology exhibited 85% or more cornified cells, the cranial vaginal vault was wrinkled and pale white, and 48 hours had elapsed since serum progesterone reached 5 ng.

The following is what we observed and did.

### 8/15/96

Vulva - swollen slightly, bright red discharge  
Cytology - 10% cornified - no red cells  
Anterior vagina - pink and smooth  
Progesterone - not run

### 8/21/96

V. - swollen - bright red discharge  
C. - 10% cornified - no red cells  
A. - pink and smooth  
P. - not run

### 8/24/96

V. - very swollen - bright red discharge  
C. - 50% cornified cells - no red cells  
A. - dark pink with folding and swelling  
P. - <2 ng

### 8/27/96

V. - very swollen - dark red discharge  
C. - 50% cornified - no red cells  
A. - pale pink and wrinkled  
P. - 2 ng

8/29/96

V. - extremely enlarged  
 C. - 65 % cornified - no red cells  
 A. - pale pink and wrinkled  
 P. - between 2 ng and 7.5 ng

8/30/96

V. - same  
 C. - 85% cornified - no red cells  
 A. - pale white and extremely wrinkled  
 P. - not done  
 Inseminated with 90% motile sperm

8/31/96

V. - same  
 C. - 90% cornified - no red cells  
 A. - same  
 P. - >7.5 ng  
 Inseminated with 90% motile sperm

9/02/96

V. - same  
 C. - 90% cornified - no red cells  
 A. - dark red and wrinkled

**DISCUSSION**

At first we had doubts as to whether Midge was actually in heat or not. She exhibited a prolonged proestrus and never exhibited any red blood cells in her vaginal cytology.

The progesterone test I used was ICG's Status Pro. It will allow one to know when progesterone values are <1.5 ng, 2 ng to 7 ng, and >7.5 ng. Ovulation is thought to occur when progesterone values reach 5 ng. Therefore, some guess work is needed for determining when this might be occurring. Also, if the serum is not removed from the red cells within 20 minutes, the test value will be erroneously low.

The progesterone test that was done on 8/29/96 indicated the value was between 2 ng and 7 ng. The color change suggested that it was very close to the 7 ng level. We deduced that the 5 ng value and ovulation had occurred on 8/28/96. Vaginal cytology and anterior vaginal exam also indicated it was time to inseminate on 8/30/96.

The expense to Polly (for the procedure) was approximately the same as it would have been to ship the female. Polly enjoyed having greater control over and being involved in the breeding process. She also enjoyed having the bitch at home.

**CONCLUSIONS**

Artificial insemination using shipped fresh chilled extended semen can be used successfully due to advances in semen extenders and new tests that allow us to pinpoint ovulation. The process is not beyond the capabilities of most veterinarians and breeders, especially if they work in concert with each other.

**Miss Caroline Reid - GLENLIVET**

October 22, 1930 - November 27, 1996

Last fall we lost a great supporter of the Scottish Terrier, a breeder of considerable note, and a friend. Miss Caroline Reid passed away on November 27, following a long battle with cancer. Known as "Miss Caroline" (in the old Southern tradition), she left behind a remarkable record as a breeder, friends too numerous to count, and a wealth of good humor.

Miss Caroline was originally from Dallas, Texas, but was educated in North Carolina. She attended both UNC and Duke and was an avid fan of each - the frequent battles between the two for the "North Carolina basketball championship" were a source of great interest and pride. She lived her adult life in Virginia and North Carolina. She began in Scotties with the old Virginia lines, Balachan, Woodhart, and Gaidoune, combining these, and some Viewpark, into the very recognizable Glenlivet look. She always gave credit to Tom and Evelyn Kirk for their friendship and guidance and maintained great respect for their opinions.

Many champions came out of the Glenlivet line, the most notable being our breed's all-time top producing bitch, Ch. Glenlivet Heather-Bell (Heather-Bell was owned by Ron and Judy Barker, "Jaudon," and produced nineteen champions), and the BIS winning Ch. Glenlivet Gordon of Jaudon. "Gordy" was campaigned for Miss Caroline by the late A.D. "Pete" Clay, who also handled many other dogs for her and used Glenlivet stock extensively in his own breeding program. Joanne and Eddie Ingram's Ch. Glenlivet Fiona was a top winner in the mid-seventies.

The consistent good nature of the Glenlivet dogs was also seen in those less famous. When Ann and I had some initial bad luck in breeding our bitch, Miss Caroline made a puppy available

to us. Glenlivet Song of the South, "Do-Da," was a charmer with a wonderful sandy-brindle coat. She didn't turn out as a show dog, but having royally entertained us for a while, "Do Da" went to Bill and Betsy Sallada, where she became "Dundee," and provided the Sallada's with years of companionship. Miss Caroline's help kept us in the show ring at a time we were a bit discouraged and eventually provided the Sallada's with years of companionship.

Visits to Miss Caroline's were always memorable. Visitors were generally required to get to know where all the dogs were (porch, kitchen, pantry, hall, basement, etc.), and which could be trusted out with each other in the front, side or back yards. When we first visited, she had nearly forty dogs and keeping all of the above straight, particularly for the late night shift, was a challenge even without a "wee dram" of her namesake single-malt. Then there were the stories. Miss Caroline had a phenomenal memory and regaled in giving her version of life on the show circuits when there were almost no Scots in the South. And, of course, no gathering of the clan was complete without someone telling a tale of one of Miss Caroline's famous "just-in-time" arrivals at ring side. (We've never been sure if she trained Gail Gaines or vice-versa.) Then there was the "Club" - The Association of Southern Scottie Handlers, Owners and ... well, if you've seen one of the pins Polly O'Neal makes, you know the rest.

I saw Miss Caroline for the last time in October on the way to and from Montgomery County. The cancer was back and getting worse. She asked that we remember her, not in sorrow, but with a "wee dram" of the Glenlivet, a funny story and a cup of kindness.

# Comparing Dog Years to Human Years

Haven't we all, at one time or another, wondered how old our dog would be in comparison to our years of life as human beings? When our pet celebrates its 5th birthday, for example, would that be comparable to us as we celebrate our 25th, or our 30th, or our 40th birthday? And how does the age of our 12-year-old canine companion compare to the ages of folks who are 60 or 70 or perhaps 90 years old? If you have ever wondered about questions like these, you have probably also seen, and puzzled over, one or more of the formulas designed for converting the age of a dog into "human years."

As an example, one simple formula advises that the answer may be found by multiplying the age of the dog by the number seven. Using this method, a dog which is 5 years old by the calendar would be 35 years old in human terms.

Another formula, which claims greater accuracy in relating ages to maturity levels, takes into account certain developmental changes which occur in young dogs. The formula is a little more complicated, but it generally works like this: After one year, a dog's age is equivalent to 14 human years. At two years, the dog's age is equivalent to 23 human years. Then, for each succeeding year, add 4 more years, combining them with the previous 23 year figure. Using this formula, the age of a 5-year-old dog would be calculated as follows: At the 2nd birthday, the dog would be 23 years old and would grow older at the rate of 4 more years for each additional calendar year. After celebrating its 3rd, 4th and 5th birthdays, this would amount to an additional 12 years. Adding the initial 23 year figure to the later 12 year figure results in a determination that the dog is about 35 years old in human terms.

The problem with these formulas is that they don't take into consideration the differences in expected life spans which are characteristic of the various breeds. In general, larger dogs, such as Saint Bernards and Irish Wolfhounds, have a shorter life span than smaller dogs, such as Dachshunds and Scottish Terriers. For this reason, if the same formula is used for both large and small breeds, the results become inaccurate and misleading. I have tired using several of these formulas, and although they all produce some numbers that could be used for comparison, I was never completely happy with the results because I knew that the answers they produced simply did not apply directly to me and my Scottie.

Then an idea came to me which allowed me to "personalize" a formula and to get results which do have a more direct relationship to me and my dog. The idea came from reading the results of a major health study which was completed by the Scottish Terrier Club of America (STCA) and published late in 1995. I had personally responded to their questionnaire during the study, and had furnished statistics about my

previous Scottie. The piece of information from that study that sparked the new idea was the simple statistic about longevity.

Based on the responses which were received from more than 450 Scottie owners and breeders, and after excluding deaths of puppies, the study concluded that the typical life span of an adult Scottish Terrier was 11.2 years. That may not be perfectly accurate but, at the moment, it is probably based on the most current data that is available.

That 11.2 year figure really struck me. After losing my previous Scottie, I had read and re-read volumes of material about coping with the loss of a pet. The statement that surprised me most was that pet owners invariably over-estimate the life span of their breed. As a result, they are quite unprepared for a death loss which is in the reasonable span of a lifetime for their pet. Based on interviews, survey-takers found that if pet owners are asked how long their particular breed is expected to live, most will give an answer that is about two years longer than is supported by actual statistics.

My previous dog was 10 1/2 years old when I lost him, which I thought was a lot younger than I believed was an "average" life span. In fact, when asked, I always told people that Scotties lived to be about 12 to 14 years old, and sometimes longer. Then, after reading the average life span statistic of 11.2 years in the STCA health study, I realized that I was one of those who was guilty of seriously over-estimating the life span of my breed. I viewed my loss at 10 1/2 years of age as unreasonably early and I was terribly unprepared for it. In my ignorance I had expected too much.

At this point, I began to wonder about how to compose a formula that would be more realistic and more helpful to me as a gauge to living my life with a Scottie. It seemed to me that two factors had to be brought into a relationship - the statistical life span of a person as compared to the statistical life span of a Scottish Terrier.

The figure for the life span of a Scottish Terrier, 11.2 years, was already in my grasp, conveniently supplied by the STCA health study.

The other figure was not difficult to supply. I know that the last time I looked at a life insurance company mortality table, the average life



span of a male born in 1938 (ME!) was 72 years. That may be slightly changed with more recent statistics, but it's certainly close enough for this calculation.

To "equalize" the difference in the length of these life times so that they can be compared, the 72 human life span years are divided by the 11.2 Scottie life span years. The result tells us how many "dog years" are contained in one human year. Thus: 72 divided by 11.2 = 6.4 approximately. So, according to this personalized formula, one human year (for me) equals about 6.4 "dog years" for my Scottie. And, to discover how old my Scottie will be in human years, I merely take his calendar age and multiply it by 6.4. As an example, when my Rusty celebrates his 5th birthday, his equivalent age in human years can be calculated by using the formula as follows: 5 X 6.4 = 32. The answer tells my that when he reaches 5 years of age, Rusty will be roughly 32 years old in my human terms.

The formula doesn't account for changes in maturity rates, and, of course, it is based solely on the statistical averages. But, even if it does nothing else, it makes me a lot more aware of how my Scottie's life is linked to my own life. We are bound together in a life-long 1 to 6.4 time relationship. When we spend a week together, it amounts to 7 days X 6.4, or a total of about 45 days in terms of a Scottie's life expectancy as expressed in my human terms. Used in this way, the formula helps me to better understand and appreciate how our times together are intertwined.

One interesting note is that the formula works the other way around, too. At present, I am nearing 60 years old. To find out how old I will be in "dog years," the formula is reversed as follows: 60 divided by 6.4 = 9.4 approximately. Loosely translated, in "Scottie Years" it means that on my 60th birthday I will be about 9 years 4 1/2 months old.

Finally, after playing with the formula and the numbers, one thing becomes very clear. With our lives racing along at 6.4 times the speed of my clock, I am sharply reminded of how very fast our companionship is traveling. Knowing that, I am moved to make the very best of these times for the both of us for as long as our numbers last. ■

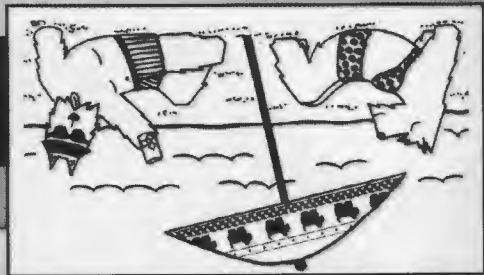

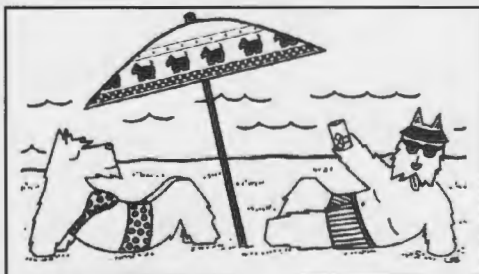

## 1,363 Scotties Are New Moms and Dads in 1996

The AKC *Stud Book Register* has intrigued me for years, and I've found it most useful. More on that later. However, I've never found another STCA member who subscribes and few who have even seen a copy. For \$75/year, subscribers in 1996 received 12 issues totaling 4,998 pages.

Scottish Terriers filled only about 20 full pages of the nearly 5,000 pages in the 1996 *Stud Book Register*. Scottie listings introduced 1,363 dogs and bitches whose first litters were registered in 1996. Most recent annual registration statistics show 2,562 Scottish Terrier litters registered in 1995. The 5,311 Scotties individually registered in 1995 made Scottish Terriers 41st among the AKC's 140 breeds in numbers of dogs registered.

### Deciphering the Stud Book

How do you read the AKC *Stud Book Register*? Look at this excerpt from January, 1997. The name of a dog or bitch appears in Column 1 only once in its lifetime -- the first time it has a litter registered. Other information in that column: titles, sex, color, AKC registration number and date of birth. Column 2 lists that dog's or bitch's sire, the date he entered the Stud Book and his registration number. Column 3 lists the dam of the animal in Column 1, with the date she entered the Stud Book and her registration number. Frequently used sires and dams whose offspring are frequently bred

appear many times over the years in Columns 2 and 3. Column 4 contains two names: the first, the person who owns the dog in Column 1; the second, the person who bred the dog in Column 1.

Magic keys for researching pedigrees are the short cryptic numbers attached to a dog's registration numbers in columns 2 and 3 -- like 11-94 or 10-91. Those numbers are the dates a dog or bitch enters the *Stud Book Register*. With only the names of the sire and dam of any given Scottie, with respective Stud Book dates, one can compile a list of ancestors ad infinitum. In the January excerpt, the bitch Abby Daba Do was sired by Carrie's Rufus Doophus. To learn the parents of Rufus Doophus (11-94), turn to the November, 1994, issue, and you'll find C & J's Laddie and C & J's Sparky. Then turn to October, 1991. Parents of Abby Daba Do's dam, Jolette's Wheat Bran (10-91) were Fisher's Winston and Brooks Candi Anni. None of the dogs behind Abby Daba Do were owned or bred by STCA members, but you can see how simple pedigree research is -- even on unknown dogs.

### Stud Book Scottie Facts

Now that you've mastered reading the *Stud Book Register*, here's what you will find in the January, 1997, issue. One hundred Scotties entered the register on their first breedings. Interestingly, Patricia Craige's new *Born to Win, Breed to Succeed* (1997) states: "For every sire registered by the stud book, there are about

30 dams recorded." This premise doesn't hold for Scotties. The ratio in January was about two bitches to one dog (67 bitches and 33 dogs). The 100 Scotties included 59 blacks, 32 brindles and 9 wheatens. Non STCA members owned 83 of the Scotties bred for the first time. Seventeen of the 100 Scotties were owned, co-owned, or bred by STCA members. The 17 dogs included one champion and 16 non champions.

My own collection of the Scottish Terrier Stud Book which goes back 27 years shows there were 183 Scottish Terriers recorded in January, 1970. Comparing the breedings of 1997 to 1970, I'd say that STCA members today are more cautious in offering their dogs at public stud and more cautious in how they sell their breeding stock. We have come a long way. Although I found no Scotties bred by STCA members in obvious commercial breeding situations in the January, 1997 issue, past registers have shown a few of our Scotties being bred by commercial operators, even into the 1990s with our greater use of spay/neuter sales agreements.

### Evolution of the AKC Stud Book

The AKC Stud Book has been around awhile. Its most important function is to permanently record the lineage of every AKC registered dog. The American Kennel Club organized in 1884 and started its Stud Book in 1887. That same year AKC was given existing breeding records back to 1878, according to AKC Secretary James Crowley. Until 1925 when the *Stud Book Register* became a separate publica-

tion, its records appeared in the club's official magazine. Originally every breeding and every AKC dog, even if never bred itself, was listed. In 1952 due to galloping registrations, the AKC switched to listing a dog (or bitch) only the first time bred. Today approximately 200,000 new sires and dams enter the *Stud Book Register* each year, estimates Crowley.

"Most national clubs have someone designated to receive the *Stud Book Register* and do research," Crowley points out. I couldn't find anyone so designated by the STCA. However, Dr. T. Allen Kirk Jr. did use early AKC *Stud Book* records to great advantage for our breed.

"He spent a lot of time in the AKC library researching pedigrees when he was a delegate. He'd often go to New York a day early to work," recalls his widow Mrs. Evelyn Kirk. Dr. Kirk started his work in the 1950s and updated his original collection of Scottish Terrier champion pedigrees with two supplements. The three-volume set covers all American Scottie champions into the mid 1970s, according to Mrs. Kirk. She donated Dr. Kirk's remaining sets to the STCA several years ago. (The "American Scottish Terrier Champions' Pedigrees" is available for \$40/set from Mrs. Evelyn Kirk, 2603 Derwent Drive SW, Roanoke, VA 24015; make checks payable to STCA.)

National breed clubs, individual breeders and rescue workers can use the AKC *Stud Book Register* to advantage. On the light side for all Scottie folks are the unusual names. Dee Dawg of Happy Cat Ranch, Mona Lisa II and Oleo's Raisin Cash are notable ones that entered the Scottish Terrier listings in January, 1997. But seriously, read on to discover the many uses of *Stud Book* records.

#### How to Use the *Stud Book Register*

(1) Research extended pedigrees on your own dogs.

(2) Prepare champion pedigrees for breed history: Perhaps an industrious Scottie fancier will continue Dr. Kirk's important work documenting pedigrees of American Scottish Terrier champions. We are about 20 years behind.

(3) Develop rescue pedigrees: Scottish Terrier rescue workers can assemble pedigrees on any rescue Scottie of known AKC parentage. For several years I have compiled rescue pedigrees here in Texas for myself and Daphne Branzell, STCA's new national rescue co-chairman. Though most rescue Scotties have obscure backgrounds, an important but infrequently used tool is to notify breeders in the first several generations behind the rescue dog. We shouldn't forget to notify commercial breeders. Because of the nature of their business, they know nothing about the dogs they produce or the offspring of those dogs. We can tell them! Ideally, STCA members up close in a rescue pedigree will contact breeders between them and the rescue dog to urge greater caution in breeding and selling. Some national clubs publish rescue pedigrees as an incentive to careful breeding and selling.

(4) Monitor breeding activity of dogs you sell: Have you wondered if someone you lost track of welched on a non-breeding agreement? The AKC *Stud Book Register* tells all!

(5) Track problem genes: If it is important to know how deeply a health problem is penetrating a breed, the breeding activity of known carriers of recessive genes and their descendants can be tracked through the *Stud Book Register*. This technique allows a very objective, quantitative and accurate picture of the spread of a disease gene. I tried this method several years ago for one up-and-coming genetic problem in Scotties. I was shocked to learn the great numbers of breeders within and without our national club touched by that disease gene.

(6) Identify commercial breeders: Why? To educate them. We won't make them stop breeding, but we can give them important health information. Also, you might prefer not to sell to commercial breeders. Do you know who they are? Unfamiliar names which appear frequently in the *Stud Book Register* are commercial breeders. I have identified many U.S. Department of Agriculture-licensed and other semi-commercial breeders of Scottish Terriers. Addresses can be linked with many frequent breeders by using USDA's annual *Animal*

*Welfare List of Licensed Dealers*. A name and address is all national clubs need to distribute health information to this hidden group of mass market breeders. The STCA has already done a bit of this. In 1995 the Health Committee sent copies of the STCA Health Survey questionnaires to about 20 USDA dealers I had thus identified. A next step might be to send commercial Scottie breeders facts about carrier frequencies of Scottish Terrier disorders. Most excitingly, we could tell large scale breeders about the new DNA test for vonWillebrand's Disease. It is likely that few of them know about it.

Interesting applications are possible with the AKC *Stud Book Register*. The fact is, the AKC *Stud Book Register* is a mother lode of information which dog fanciers haven't started to mine.

As the new STCA Rescue Coordinators, we are looking forward to working with the STCA Board and Membership, and trust we can count on help and cooperation from everyone. We feel very strongly that we are all responsible for every member of our breed, no matter how he or she arrived on this earth. You and I did not breed that unfortunate Scottie in the local shelter, but the irresponsible person who did is not going to save him from the gas chamber. It is up to each one of us - the responsible Scottie people. There are vast expanses of the USA that are not near a regional club or rescue organization. If you live in one of those areas, you may be called upon to help if a Scottie is in harm's way. We trust that you will respond willingly and promptly. If you are a breeder, please mention the rescue program and the many Scotties needing good homes when you have inquiries about puppies. Many people could provide a wonderful home for a rescue Scottie, but cannot afford the price of a quality puppy. We welcome your comments and suggestions. As a regular feature in the *Bagpiper*, we will introduce you to some of the dedicated people in our breed, who are earning stars in their crowns by helping less fortunate Scottish Terriers. The spotlight in this issue is on the Scottish Terrier Club of New England (STCNE). Scottie Rescue has always been very important to the STCNE. Until 1995, Barbara Albright and then Karen Phillips coordinated the Club's rescue efforts. Both were very dedicated and were responsible for saving many Scotties. Initially this program was operated by putting together potential owners with dogs needing homes, with financial help when needed from the Club's treasury. No legal problems had been encountered, but it was obvious that a lawsuit was waiting to happen. A committee was formed, chaired by Jim Orsborn along with Joyce McNabney, Barbara Lounsbury, and Scott Rutherford. They collected and reviewed rescue policies from other breed clubs and some of the other Scottish Terrier regional clubs, notably the Michigan STC. New guidelines, policies and procedures were drawn up and presented to the STCNE Board. These were unanimously approved in January 1996. Jim Orsborn is Chairman of the rescue commit-

tee, assisted by committee members Linda Orsborn, Jeni and Bill Walsh, Barbara and Charlie Lounsbury, and Scott Rutherford. These people, plus Sharon Alessandrini and Norma Bouchard, serve as foster homes. All rescued dogs are placed in foster homes for a minimum of two weeks, sometimes longer. They are evaluated for temperament and health problems, spayed or neutered if necessary, heartworm tested, vaccinated, and socialized. The foster home evaluates the Scottie by exposing it to car rides, crowds, children, other dogs and general everyday experiences. Funding was a prime concern when this new program was started. The STCNE now has a separate fund for rescue that is approximately 50% of the total budget. During the first year of operation 17 dogs were taken in and total expenses were \$3200. The income comes from adoption fees, raffles, donations and an auction at the annual banquet, with expert help from auctioneer Beverly Cromwell. The adoption fee was recently raised from \$100 to \$150 to be more in line with actual expenses. The rescue operations of the STCNE cover all six New England states, so there are large transportation and telephone expenses, as well as the veterinary charges. Liability is covered by the STCNE insurance policy. Application forms are filled out by prospective owners, and 150 requests were received during 1996. The dogs ranged in age from 6 months to 10 1/2 years, and boys outnumber girls by two to one. Most are healthy, well-socialized dogs, but some came from sad circumstances and required a good deal of time and care. Jim Orsborn gives credit for the success of this program to the foster home concept and the great financial backing of the STCNE and its membership. A really nice touch is the presentation of adoption certificates to new owners at the STCNE matches in the Spring and Fall. Their written guidelines are very thorough and very well written, and they would be happy to share them with any of the regional clubs who are considering a formal rescue program.

Barbara Lounsbury has written some wonderful stories in the STCNE newsletter "Scottie Tails" about the rescue dogs she has fostered. With her permission, the story of "Bonnie Jean," which illustrates both the joys and sadness of rescuing a Scottie, is reprinted for your enjoyment.

## Bonnie Jean

I miss her. For two weeks she was my constant companion. Bonnie Jean and the flu arrived almost simultaneously. When her owner called, I tried to suggest that she think it over for a few days. She spoke to Linda. The dog had to go. Would I be able to take her? Of course, said I, wondering how I would manage to get dressed, walk downstairs, speak intelligently to this woman, and tend to a new and, most likely, unsettled dog. She arrived only a few hours later, Bonnie Jean in tow. The lady was well-spoken, and unemotional. Bonnie Jean was clean and appeared well-cared for. She came with her vitamins and her heartworm medication, labeled carefully so that the next owners would know to administer the tablet on the 28th of each month. Her owner was upset when she realized that she had forgotten Bonnie Jean's favorite toy. Yes, she was housebroken. Yes, she had grown up with a child. No, she didn't have any bad habits. She wore a new collar, with matching leash.

I craned my neck to read upside down what the woman was writing as the reason for giving up the dog. "Serious illness in the family," it said. She declined to discuss it. I didn't press. She apologized for her attempts at grooming, which included clipping Bonnie Jean's back down tight, leaving a full ruff and head of hair like an Aussie and full bush of a tail like a Cardigan Corgi. A strange looking beast, and undoubtedly the largest Scottish Terrier I've ever seen, Bonnie Jean entered my life by making it abundantly clear that crating was not in her repertoire. While her departing owner was still in earshot, she began to bark hysterically and didn't stop. Too ill to put up with the noise or find a more creative solution to the problem, I opened the crate door, said, "C'mon, Bonnie Jean," and crawled back upstairs to my sickbed. Bonnie Jean leaped up on the bed, found a comfortable spot at the foot where she would not intrude on my space, and promptly fell asleep. And here, except for occasional outings, she stayed for the next four days. When I finally felt like eating, Charlie would prepare a tray and keep me company while I ate. So would Bonnie Jean, lying in her usual place at my feet. Although the tray and a tantalizing array of food were only a few feet away, she never begged nor even budged. She left me

only long enough to go outside, take care of business, or have a quick dinner. And then she was back. When I returned to work, Bonnie Jean had to accept the indignity of spending the day in the kennel, but each evening, as soon as she was released from her incarceration, she bounded to the gate which would allow her into the kitchen. And from that moment each evening, until she was taken to the kennel the next day, she never left my side. Her owner had brought her "papers," the blue slip which had accompanied her at puppyhood. Purchased from a local woman "whose friend breeds Scotties in Pennsylvania," her papers revealed that, in spite of her white muzzle, she was only 5 1/2 years old, bred in Lancaster County. This area now has the largest collection of "puppy mills" in the US, where dogs are a cash crop. Often raised in dark and filthy barns, bitches are bred each and every heat until they die of exhaustion or disease, babies are raised with no human contact, packed in crates at the earliest possible age and shipped to pet shops throughout the country, where unsuspecting buyers fall for the "AKC puppies" line, thinking that it means something. The pet shop in my local mall assures me that they don't patronize the puppy mills - *their* puppies come from wonderful kennels run by loving people whose only motivation is to raise well-adjusted, healthy babies for people like me to love. Yeah, right. Then why won't they let me see the registration certificate until *after* I pay for the dog? What is there to hide? The fact that the puppy by Bart out of Bobbie was bred by someone in Lititz, Pennsylvania? Not a puppy miller, eh? I'd bet my life on it.

I inquired what the woman had paid for the eight-week-old Bonnie Jean. As much as I charge for my babies, it turns out. "Oh, you're a breeder, too," she exclaimed, lumping me together with this despicable woman who brokers puppy mill babies out of her kitchen. No point in the lecture. She would have a hard time accepting the fact that she had done something unsavory.

Bonnie Jean's good health and good temperament prevailed in spite of indifferent genes and uncaring husbandry. She was a hopeful, loving and forgiving creature who accepted us as if she had lived with us all of her life. Except for her daily vigil at the kitchen window when the school bus brought the neighborhood kids home. And for those brief moments each day, she broke my heart. I would have kept her forever if I could. But the time came when she needed to find a permanent place. Jeni Walsh had a co-worker who would provide the perfect home. And so I gave her up. Of course, I cried. I still do.

For all of them. ■

work, Bill answered, "I decided to do it," and that is exactly, 203 dogs rescued later, what he has done. He notes that the success of STCGNY's rescue committee is due in great part to the invaluable help of Marion Krupp.

The Rescue program started with \$500 seed money from the Club, which has been repaid to the treasury. Bill comments that STCGNY Rescue continues to do well for several reasons. It serves an area with a large population base where the demand often exceeds the supply. Also, Bill and Marion often work with other regional Clubs in rescuing Scots and in placing them in new homes. The only frustrations are owners who do not care for their Scotties and those few people who do not appreciate receiving a rescue dog enough to send a small donation to the Club.

One of Bill's most memorable rescues occurred in 1988, when two Scotties were found tied to a parking meter at 97th Street and FDR Drive in New York City. With them were their papers and a copy of John Marvin's book on the Scottish Terrier. They now have the run of a farm in Mendham, an upscale neighborhood in New Jersey.

Bill had a rescue Scottie of his own who had an interesting history. "Mac" belonged to a well known actor who performed with Sid Caesar and Imogene Coco in the golden days of television. Unfortunately, the man came to a sad end in Morristown. Since "Mac" was 10 1/2 years old, he was not a good candidate for rescue, so Bill adopted him, and he lived to the happy age of 14 in the Berry household.

Bill just completed a two year "matter of fact" tenure as National Rescue Chairman for the STCA. STCGNY is fortunate to have Bill heading up its rescue work.

The STCGNY held its annual Holiday Dinner at The Publick House in historic Chester, New Jersey. Members and guests were treated to fine food and fare provided by the restaurant staff and coordinated by chairperson Cynthia Urban. Many thanks to her.

# Agility in the Works for Montgomery Weekend

Plans are underway for STCA to hold its first AKC Sanctioned A Agility Trial! If approval is finalized at the March board meeting, then it will be held in conjunction with the 1997 Montgomery County Weekend. It will be in the horse arena on the grounds of the LuLu temple, in the morning between Obedience and Sweeps. We not only will be able to prove our Scots have beauty and brains, but also tremendous athletic ability!

To make this event a success we need as many members as possible to participate. For those of you already competing or training in agility, this will be a great opportunity to get a leg towards a title. All 3 levels will be offered. For those who have not tried this wonderful sport, there is still plenty of time to get out there and train.

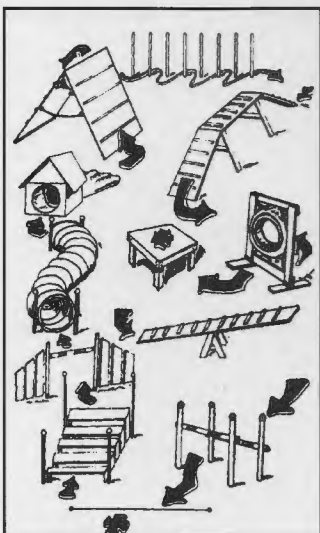
The trial will be run according to AKC Agility rules. To familiarize yourself with these rules you can contact the AKC Agility Department and ask them to send a rule booklet.

To spark your interest and get you started, I will give you some idea of what is expected of an agility team (you and your Scot). One team at a time must negotiate a numbered course of 12-13 obstacles (Novice) in a given time without the aid of a leash, whistle, food, toys or touching your dog or an obstacle. The obstacles consist of an A-Frame 4 ft. 10 in. to 5 ft. 6 in. tall, a dog walk that's 36-48 inches tall with 8-12 foot sections, a seesaw that's 12 ft long, an open and closed tunnel, a tire or window jump, a pause table, where the dog has to either do the sit or down for 5 seconds, a broad jump and various solid, single bar, and combination jumps. Scotties jump at 8 to 12 inches, depending on shoulder height. No bitches in season are allowed. All dogs must be 12 months or older to participate.

The Novice class has an opportunity to try their dog on the 3 contact obstacles before the class. This may be done on leash. However, no treats may be used. All 3 levels are given an opportunity to walk the course without their dog. This gives you a chance to plan your route, check equipment, and check the footing for both yourself and your dog. When competing, you must have your dog under control at all times. You can use your voice, hand and body signals to achieve this. The dog also has to have a working vocabulary of the obstacles. You can name them whatever you like, but be consistent so the dog doesn't become confused. Your dog must be able to go into a sit or down and stay for 5 seconds without being touched. No other formal obedience is really necessary.

As you and your dog train for this sport, you will both benefit from the physical exercise. A

minute competing in the ring doesn't seem like much exercise, but your Scot has to work very hard on those little short legs. Some of the training can be done right in your home or backyard. Be imaginative in creating obstacles. They don't have to be the real thing, but make sure they are safe. If you decide to train with an Agility Club there will be lots of people to help and encourage you. When learning the contact obstacles, always train with a spotter to prevent falls. Never train on the obstacles with a choke collar on your dog. Don't force your dog to do obstacles before he is ready. Most of all be patient and consistent in your training. It doesn't happen overnight! I hope all of you will give it a try. It's a great deal of fun! This is a sport for the young or old, human or canine. If you have an older retired champion that has turned into a



couch potato, give him a new lease on life and try Agility! As long as he's physically sound and can hear and see well, he can participate. How about you? Are you a couch potato? As long as you are physically sound and can see and hear well, you can participate. Go for IT! My husband just started training a seven year old Scottie, and after a few lessons she is already able to do the course faster than him. We hope we will have participation from some juniors. My daughter, who is now 14, has been doing Agility with our Scotties ever since she was small. We just didn't know it was called Agility. She loved to set up obstacles made from cardboard boxes, scrap lumber and her gym set. Puppies as well as oldsters enjoyed the exercise and all the extra attention. Last year she put a Novice title on her beloved Scottie, Pip, a seven year old. She has high hopes for a master's title. So you can teach an old dog new tricks!

The day of the trial be sure to wear comfortable clothes and shoes that give you good traction. Bring your camera, a sense of humor, extra oxygen (if you get winded), a big cheering section, an umbrella so it doesn't rain and of course, the star of your life, your Scottie.

Finally, if you choose not to run your Scottie but want to learn about Agility, we will be needing volunteers to help set up and take down equipment, score-keepers, ring stewards, timers, and scribes.

If you have any questions, comments, inputs, or want to volunteer, you may contact either me or Connie Smith. We also need feedback to give us an idea of how many of you are interested in actually running your Scot.
