**Complaint of the 9/11 Families to the Inspector General
regarding the willful misconduct of one or more FBI officials
in their handling of key evidence from the 9/11 investigation**

We, the undersigned 9/11 Families, present this Complaint to request that the Inspector General investigate the FBI's statements made in response to our subpoena in the 9/11 litigation that the FBI "lost" or is simply no longer able to find key evidence about the individuals who provided substantial support inside the U.S. to the 9/11 hijackers.

The Inspector General should examine whether one or more FBI officials committed willful misconduct with intent to destroy or secrete evidence to avoid its disclosure. Given the importance of the missing evidence at issue to the 9/11 investigation, as well as the repeated mishandling by the FBI of that evidence, an innocent explanation is not believable.

It appears that the motive for these acts was to hinder review of the FBI's 9/11 investigation and avoid embarrassment of the FBI for its failure to pursue cases against the terror co-conspirators who provided critical support to the 9/11 hijackers. In 2004, the FBI provided Congress with incorrect testimony concerning the support network for the 9/11 hijackers. Rather than fix that record and face the consequences, one or more FBI officials chose to impede production of the evidence that would reveal the agency's mistakes.

Until last month, the FBI assured the 9/11 Families that it was still pursuing an "active" investigation of the terror conspiracy to support the 9/11 hijackers and used this to argue against disclosure. Then on August 9, 2021, after thousands of 9/11 Families asked President Biden to order the release of the 9/11 investigation files, the FBI suddenly announced that its 9/11 Subfile Investigation had been closed, and the FBI would "re-review" its 9/11 files to determine if more material could be disclosed.¹ Thus far, no additional substantive material has been produced, and the FBI has not agreed to make a further effort to find its missing documents.

The FBI has a duty to retain its 9/11 evidence and has sophisticated computer systems to maintain its files and run searches on them. A routine search must be able to locate critical documents from the most serious criminal investigation ever conducted by the FBI.

This Complaint stems from the subpoena for documents served by the 9/11 Families on the FBI in April 2018 in their lawsuit against the Kingdom of Saudi Arabia pending in the Southern District of New York, *In Re: Terrorist Attacks on September 11, 2001*, 03 md 1570 (GBD-SN).

The lawsuit states that Saudi government officials in Los Angeles and San Diego provided critical assistance to the 9/11 hijackers upon their arrival in California. For over three years, the 9/11 Families have waited for the FBI to produce key evidence in compliance with the subpoena.²

The Inspector General is the only official who can properly investigate this matter on behalf of the 9/11 Families.

1. The Missing Videotape of the Saudi government official and the 9/11 hijackers

The FBI lost, hid, or destroyed a key videotape showing a Saudi agent, Omar al Bayoumi, hosting a party in San Diego for two 9/11 hijackers Nawaf al Hazmi and Khalid al Mihdhar shortly after their arrival in the U.S. Hazmi and Mihdhar were known al Qaeda operatives and the first of the 9/11 hijackers to arrive in the U.S. The FBI's claims that it cannot locate this key piece of evidence must be investigated.

In February 2000, Bayoumi, a Saudi government official working undercover in San Diego, met Hazmi and Mihdhar in Los Angeles and a day later Bayoumi was hosting the two men in San Diego. Hazmi and Mihdhar stayed at Bayoumi's apartment for several days while Bayoumi helped them find an apartment in the same complex; assisted them to open a bank account; obtained the certified bank check they needed as a deposit before moving in; and provided them with an English/Arabic speaking aide. Bayoumi also introduced them to San Diego imam, radical jihadist, and al Qaeda recruiter Anwar al Aulaqi.

Bayoumi organized a party at the hijackers' apartment shortly after they moved in and invited approximately 20 hand-picked guests from the local community. The objective of the so-called party was to infiltrate Hazmi and Mihdhar into the community and introduce them to potential co-conspirators in the plot.

One of the attendees recorded the party on a video camera. The FBI obtained a copy of the videotape, used it to question various witnesses, and provided a copy of the video to the 9/11 Commission.³

The 9/11 Families asked the FBI to produce a copy of the party videotape. For over two years the FBI evaded the request and refused to provide the videotape, and ultimately claimed that it could not locate this key piece of evidence.

Brian Gilhooly, Deputy Assistant Director of the Counterterrorism Division swore under penalty of perjury on April 8, 2020: "The FBI performed Sentinel searches and conducted physical searches to locate the videotape. The FBI has made additional inquiries with agents and other FBI

employees who previously worked on PENTTBOM and might be aware of the location of other copies of the videotape, but thus far it has not been located.”⁴ Relying on this declaration, Magistrate Judge Sarah Netburn found that the FBI had exhausted all possibilities of finding the tape, denying the 9/11 Families’ request for further searches for that key video.⁵

2. Missing FBI records of interviews of key witnesses

The FBI lost, hid, or destroyed numerous records of interviews that FBI agents conducted of various individuals. These include summaries of interviews taken of individuals associated with the King Fahad Mosque in Los Angeles, where Saudi diplomat Fahad al Thumairy arranged support for hijackers Hazmi and Mihdhar immediately upon their arrival in the United States.

The FBI interviewed directors, employees, and congregants of the King Fahad Mosque – all of whom are likely to have had important information about Thumairy and others involved in assisting the hijackers. The 9/11 Commission Report names a number of witnesses at the Mosque who were questioned, including several who identified Thumairy as an extremist.⁶ But after conducting searches, the only interview summaries produced by the FBI were from the Mosque’s director and a single congregant, despite the fact that its agents conducted numerous other interviews.⁷



In addition, the FBI was unable to locate other key witness statements. As an example, while the 9/11 Commission Report states that there is a January 15, 2002 FBI interview of key witness Mohdar Abdullah, the FBI reported that its “searches did not locate any interview report for Mohdar corresponding to this date.”⁸

Whether by intent or incompetence, the FBI has failed to produce interview summaries that they admit are clearly relevant to and within the scope of the 9/11 Families’ subpoena. This failure to locate key evidence must be investigated.

3. Missing Phone Records of calls among the 9/11 co-conspirators

The FBI lost, hid, or destroyed records of phone calls among the key conspirators. The FBI's failure to locate the telephone records and its highly questionable method of maintaining them must be investigated.

Various witnesses have repeatedly attempted to deny contacts among one another and with 9/11 hijackers Hazmi and Mihdhar. Call records maintained by third-party telephone providers have been instrumental in undermining those denials. Because of the passage of time, however, those providers no longer have the records. During its investigation, the FBI timely obtained the telephone records of key individuals involved in the planning and support of the 9/11 hijackers. But the FBI failed to produce many of those records to the 9/11 Families, claiming that they cannot be located.

For example, the FBI could not produce large blocks of the home and cell phone records during critical time periods for Bayoumi, Thumairy, and Mohdar Abdullah – all of which the FBI obtained and should still be able to locate.⁹ Nor did the FBI produce any phone records of the individuals who were in direct contact with Bayoumi, Thumairy, and 9/11 hijackers Hazmi and Mihdhar, including Fathi Aidarus, Mohamed Johar and Anwar al Aulaqi. The phone records were identified by the 9/11 Families consultant and former FBI Special Agent Catherine C. Hunt who conducted an independent investigation for the Plaintiffs.¹⁰

The FBI claims that it could not locate the phone records because it did not make electronic copies—despite the importance of the records at issue and the fact that the FBI had in place a computerized search system for every document it collected.¹¹

The FBI's document management system was either (a) in such disarray as to interfere with the production of key phone records concerning the largest crime in U.S. history or (b) stored the documents in a manner that they could not be located. Either conclusion shows gross negligence or willful misconduct.

4. Missing Photograph of Saudi diplomat Thumairy with the 9/11 Hijackers

The FBI lost, hid, or destroyed a photograph showing Thumairy with 9/11 hijackers Hazmi and Mihdhar outside of the King Fahad Mosque, which would directly disprove Thumairy's implausible insistence that he had never met the two men.

According to the deposition testimony of a senior director who worked at the Mosque, FBI agents showed this photo to King Fahad Mosque personnel following the 9/11 Attacks. Now,

however, the FBI is claiming that two case agents were not aware of the photograph and that its search did not reveal the photograph.

If, indeed, the FBI cannot locate this photograph documenting the meeting between 9/11 hijackers and Saudi diplomat Thumairy soon after the hijackers arrived in the United States, this is a gross dereliction of the agency's duties and responsibilities and must be investigated.

5. Missing Joint FBI-CIA Intelligence Report about Saudi Arabia's 9/11 involvement

The FBI (and the CIA) lost, hid, or destroyed a joint intelligence report that assessed the nature and extent of Saudi government support for terrorism, which was prepared and submitted in accordance with the Intelligence Authorization Act for FY 2004, Classified Annex S. 1025/S. Report 108-44.¹² A nearly completely redacted copy of the report was made public in 2005, but the FBI was unable to find its own original document without redactions.

Amazingly, this report, which documents findings by United States law enforcement agents and intelligence officers detailing the official role that the Kingdom of Saudi Arabia played in providing material support for terrorist acts could not be located.¹³

Failing to locate and produce a copy of this report is, at best, gross negligence and must be investigated.

6. The 2004 testimony of the FBI demonstrates the FBI's motive to hide or destroy documents

FBI Special Agent Jacqueline Maguire was assigned to the PENTTBOM investigation in October 2001.¹⁴ She was involved in critical stages of the investigation and, among other things, in February 2004 accompanied investigators with the 9/11 Commission to the Kingdom of Saudi Arabia to interview Thumairy – the Saudi diplomat who first arranged for shelter for 9/11 hijackers Hazmi and Mihdhar upon their arrival to Los Angeles.¹⁵

In connection with her role on the PENTTBOM investigation, Agent Maguire appeared before the 9/11 Commission, testifying under oath. On at least two occasions, Agent Maguire's testimony contained material factual misstatements.

On June 16, 2004, Agent Maguire appeared before the 9/11 Commission and reported extensively about the investigation of Mohdar Abdullah.¹⁶ Though Abdullah had admitted to

FBI agents that he had taken 9/11 hijacker Hazmi to the King Fahad Mosque where they met Saudi official Thumairy, and FBI agents in Los Angeles concluded in January 2002 that “Mohdar, al Hazmi and al Mihdhar attended the King Fahad Mosque on 06/09/2001,” Maguire testified under oath that there was no evidence that Hazmi (or Mihdhar) had ever gone to the King Fahad Mosque.¹⁷ This statement was demonstrably false and Agent Maguire, who had been involved in the PENTTBOM investigation at that point for well over two years, should have known it to be false.

Further, 9/11 Commissioner Roemer asked Agent Maguire during her testimony about a June 2001 CIA notification to the FBI. Maguire testified under oath that she could not have seen that notification because she was still training at Quantico at the time.¹⁸ But in a Declaration filed in the United States District Court for the District of D.C. on September 9, 2005, Agent Maguire stated that she graduated from Quantico in June 2000 and worked at the FBI’s New York Field Office until October 2001.¹⁹

Likewise, a press release from the FBI issued in December 2019 states that Agent Maguire joined the FBI in 2000, and was assigned to the New York Field Office as a member of the Joint Terrorism Task Force, information that is consistent with Agent Maguire’s 2005 Declaration.²⁰

Commissioner Roemer’s question to Agent Maguire was about the distribution to the FBI in June 2001 of detailed information from the CIA that Osama Bin Laden had been preparing operatives to go to the United States for an upcoming attack.²¹ This information fell squarely within Agent Maguire’s terrorism responsibilities in the New York City field office and would have been a matter of red flag importance before and after 9/11. Yet Agent Maguire denied knowledge and avoided further questioning by falsely stating that she was still studying at Quantico when the information was transmitted to the FBI.

The Inspector General must investigate whether Agent Maguire’s contradictory sworn statements were made intentionally to divert further questioning by 9/11 Commissioner Roemer about the FBI’s receipt of the CIA information.

7. The FBI made false or misleading statements that its Subfile Investigation was open and active when it was actually closed or abandoned

In 2019, and again in 2020, the FBI told the United States District Court for the Southern District of New York that document production to the 9/11 Families must be restricted because the FBI’s Subfile Investigation, also called “Operation Encore,”²² remained “open” and “still pending and active.”

On April 8, 2020, Brian Gilhooly, the FBI's Deputy Assistant Director, Operations Branch, Counterterrorism Division declared that the Subfile Investigation was "pending and active."²³ Michael McGarrity, the Assistant Director of the FBI's Counterterrorism Division declared in September 2019 that PENTTBOM and the Subfile Investigation remained open.²⁴ Duel Valentine, a Supervisory Special Agent in the FBI's Counterterrorism Division on November 1, 2019 stated that the 9/11 investigations were pending.²⁵ Jill Sanborn, the Assistant Director of the FBI's Counterterrorism Division stated in May 2020 that PENTTBOM remained open.²⁶

The 9/11 Families challenged these contentions with proof that a decision was made by the FBI in 2016 to effectively shut down the investigation, as reported in a New York Times story and evidenced by the lack of any substantive investigation documents.²⁷

The district court relied on the FBI's declarations to limit discovery because of an "active" investigation.²⁸

Then, on August 9, 2021, the FBI abruptly wrote the federal court that the Subfile Investigation had been closed.²⁹

The Inspector General should investigate these representations made to a United States federal court and determine whether the investigation had effectively been closed when the FBI submitted its declarations and other papers to the federal court. The FBI should not be allowed to assert that an investigation is "open" in order to avoid the production of relevant and responsive documents.
