

HOLDING COMPANY ACT RELEASES

## GEORGIA POWER COMPANY

A supplemental order has been issued authorizing Georgia Power Company ("Georgia"), an electric public-utility subsidiary company of The Southern Company, a registered holding company, to issue and sell up to an aggregate amount of \$250 million principal amount of variable rate first mortgage bonds from time to time through December 31, 1989. Jurisdiction has been reserved over other matters proposed in the amended application-declaration pending completion of the record. (Rel. 35-25006)

THE COLUMBIA GAS SYSTEM, INC.

A supplemental notice has been issued giving interested persons until January 16 to request a hearing on an amended proposal by The Columbia Gas System, Inc. (Columbia), a registered holding company to establish a Leveraged Employee Stock Option Plan (LESOP) which would issue through December 31, 1990 up to \$200 million of debentures guaranteed by Columbia. The proceeds of the LESOP borrowings will be used to purchase Columbia common stock in order: to meet Columbia's obligations for 15 years; to match Columbia system employees' contributions to the Employees' Thrift Plan, Fund B, which provides for investments in Columbia common stock. The LESOP will purchase outstanding shares of Columbia's common stock on the open market and up to 2.5 million shares of authorized but unissued common stock from Columbia, which Columbia proposes to issue and sell at prevailing market prices. The original application, which was noticed on August 31, 1989 (Rel. 35-24946) proposed that the LESOP issue debt in the form of medium-term notes rather than debentures. (Rel. 35-25007)

# SELF-REGULATORY ORGANIZATIONS

### PROPOSED RULE CHANGE

The <u>Chicago Board Options Exchange</u> (SR-CBOE-89-24) has filed a proposed rule change under Rule 19b-4 to permit members to receive market-making appointments that extend to all options classes traded at up to five trading stations, instead of the current limit of three stations. In addition, the CBOE proposes to clarify that a DPMaffiliated market maker is prohibited from including in its appointment zone a trading station at which the affiliated DPM is assigned. Publication of the proposal is expected to appear in the <u>Federal Register</u> during the week of January 8. (Rel. 34-27566)

## NOTICE AND IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

Proposed rule changes filed by the following exchanges for the specified purposes have become immediately effective under Section 19(b)(3)(A): <u>Chicago Board Options</u> <u>Exchange</u> (SR-CBOE-89-25) - to incorporate into CBOE rules its existing policy regarding position limit exemption requests from market-makers (Rel. 34-27569); and the <u>Pacific Stock Exchange</u> (SR-PSE-89-30) - to modify its equity transaction rates applying to monthly trade values (Rel. 34-27570). Publication of the orders is expected to appear in the <u>Federal Register</u> during the week of January 8.
